

Mecham ordered Colter to write state fund check says House investigator

PHOENIX — Gov. Evan Mecham ordered his chief of staff Jim Colter to write an \$80,000 check from a state fund to help bail out a sour Mecham Pontiac business deal and then forced Colter to cover up the loan, a House investigator said Monday.

Ron Woods, a private investigator hired by the House to assist special counsel William French in the Mecham investigation, told the 10-member committee that Colter said during a December interview that he had advised Mecham against using the governor's protocol fund for private purposes, but Mecham ordered him to write the check anyway.

Woods said Colter, as a Mecham employee, followed orders and issued the check. The check has become the centerpiece of allegations of embezzlement leveled against Mecham by French in a report issued to the House Jan. 15.

Mecham allegedly used the \$80,000 to make a payment on a piece of property in Tacoma, Wash., owned by his Glendale Pontiac dealership. The loan was repaid Oct. 23, 1987.

Colter was scheduled to testify today, but Committee Chairman Jim Skelly said he

learned early Monday that Colter was in Australia and would not be returning for several weeks.

The protocol fund was set up last spring from about \$92,000 in proceeds from Mecham's Jan. 5, 1987 Inaugural Ball. Mecham had wanted to use the funds to pay off his campaign debts, but the Maricopa County Attorney's office issued an opinion saying use of those funds would violate state campaign contribution laws.

In May, Mecham agreed that the funds should be deposited in a gubernatorial protocol fund and be used to promote the state.

Woods said Colter told Mecham it would be "foolish" to loan the money to Mecham Pontiac, but Mecham did not heed the advice.

Mecham later ordered Colter not to file the deed of trust with the Maricopa County Recorder's office, although that would have been standard procedure, Woods said.

Woods, one of three witnesses to testify Monday on Mecham's handling of the protocol fund, added that, "Mr. Colter's feeling was that he was an employee of the governor . . . and that's why he wrote the check."

Woods also said that French's investigation turned up two more

questionable uses of the protocol fund — a \$296 check to pay for round-trip airfare to Salt Lake City for the governor and his wife and a \$2,200 check to Fidelfacts, a private investigation firm that conducted a sweep of the governor's office for bugging devices.

Warner Lee, the attorney for the Mecham Inaugural Committee, told the six Republicans and four Democrats on the panel that he was "very disappointed, very

surprised" at Mecham's use of the protocol fund, but added that "minds could differ" on whether the protocol fund was state money.

Earlier, Howard Schwartz, deputy Maricopa County Attorney, testified that during a meeting between the Inaugural Committee and county attorneys, that the group decided the protocol funds would be state monies.

FIJIs ask University board to drop hazing charges

The Phi Gamma Delta (FIJI) fraternity has asked the University Hearing Board for dismissal of its pending ASU hearing into charges of hazing, and FIJI attorneys say they are prepared to take the case to Maricopa County Superior Court if their motion is denied.

The University Hearing Board will convene Thursday and Friday to determine if the FIJIs were guilty of hazing during the 1986 and 1987 school years. The Office of Student Life recommended the FIJIs lose their house and registration as a campus organization for two years, beginning Dec. 19, but their appeal to the hearing board allowed them to stay on campus.

Laurie Shanks, a Maricopa County public defender hired to represent the University in the FIJI case, said she may ask for stricter sanctions.

But FIJI attorney Terry Davis said, "We could still be at this next year," explaining that his Phoenix law firm, Susemihl, Davis and Kelly, will leapfrog the University disciplinary system by taking its case to Superior Court if

ASU President J. Russell Nelson does not tender an agreeable final decision.

After testimony Thursday and Friday (and any subsequent hearings), the board will make a recommendation to Nelson for his approval, denial or amendment.

ASU Legal Counsel Bruce Meyerson said Monday he had not heard that the FIJIs may take their case to superior court if they find the University's final decision unfavorable. "I haven't really evaluated that," Meyerson said.

"I wouldn't want to speculate on what the outcome (of the University hearing) would be," Meyerson said. He added that the Arizona Board of Regents would probably be named as a defendant if the case were appealed to superior court.

Arizona Board of Regent counsel said it is standard procedure for the board to be named in such cases since it is the governing body of the state universities.

Davis admitted the FIJIs have done some "stupid" things, but he added that banning the FIJI house from ASU is a "punishment that doesn't fit the crime."

"I would be in favor of any kind of strict probation the University wants to hand down, because I think it's

appropriate," said Davis, a University of Iowa graduate FIJI.

The FIJI dismissal motion is based on the contention that Arizona universities do not have the power to regulate "organizations," but only "students, faculty and other staff." The appeal contends Arizona statutes do not specifically state the Board of Regents can authorize universities to adopt codes of conduct.

"Under current law, the Arizona State University Hazing Regulation adopted Jan., 1986, . . . is not enforceable against an organization," the motion states.

A spokeswoman for regent counsel said, "Universities have the right to regulate their own campuses and environments."

Since the board is not yet involved in the FIJI case, the spokesman said counsel is not prepared to respond to the legality of the board authorizing codes of conduct.

In Jan. 1986 fraternities were required to sign a statement promising not to break the policy. All ASU fraternities signed the statement, according to Shell.

Babbitt asks election commission to decide legality of contribution

Democratic presidential candidate Bruce Babbitt has asked the Federal Elections Commission to decide whether a Phoenix lawyer's \$5,000 payment for a direct mail list violates federal campaign contribution laws, the campaign's national chairman said Monday.

Federal elections law limits individuals' campaign contributions to \$1,000.

Chairman Duane Garrett said he learned of the controversy Sunday night and FEC officials were asked Monday to review the the payment from Robert Stephan Jr., who paid for half of the \$10,000 direct mailing list compiled by the Iowa State Democratic party.

The remaining \$5,000 was footed by the Babbitt for Arizona Committee, Babbitt's political action committee. BAC's contributions are limited to \$5,000 for each candidate.

The former Arizona governor purchased the list of about one million names last year to help in his direct

mail campaign, Vada Manager, a Babbitt spokesman, said.

Reports circulated Monday that Babbitt, along with Missouri Rep. Richard Gephardt, also a Democratic presidential contender, purchased the lists from the Iowa Democratic Party in a manner that may violate federal contribution laws.

Gephardt appeared at Iowa Democratic Party functions in exchange for the list.

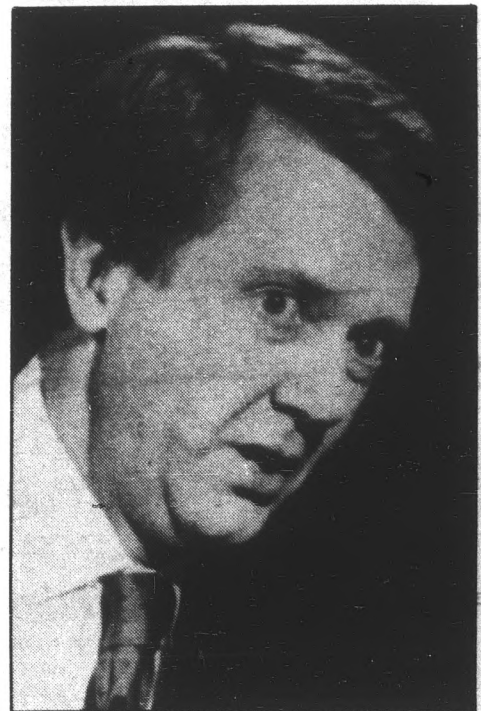
Gephardt press secretary Mark Johnson said the Gephardt campaign will not ask for a FEC investigation.

"We are reviewing the situation but at this point we don't think it's a violation."

Garrett denied that the campaign intentionally violated any laws, saying that presidential campaigns do not become official until January 1987, and Babbitt's Iowa effort constituted a political action committee.

He said any violation would be in a "pretty technical area."

160 coal workers trapped in mine in northern Mexico; 17 men saved

MEXICO CITY (AP) — An explosion and fire trapped about 160 men in a coal mine in northern Mexico on Monday, authorities said. They said 17 were rescued by mid-afternoon.

Americo Juvenal Soto Rodriguez, police chief in the town of La Esperanza near the mine, said the blast occurred in the morning and the fire was making rescue work difficult.

"Rescue squads are working on it, and we have firemen from the (nearby city) of Monclova ... It is doubtful they could be brought out (alive)," Soto Rodriguez said in a telephone interview.

The Fire Brigade at Monclova, a city 71 miles south from La Esperanza, said there were 26 firemen, three water tank-trucks and one fire truck at the scene of the disaster.

Martin Flores, the Fire Department duty officer at Monclova, said in a telephone interview that rescue reinforcements are being rushed from Saltillo and half a dozen communities in the area to the scene of the disaster.

"Things are very hard down there," Flores said. He said he had talked by radio with Fire Brigade Commander Jose Armando Tijerina, coordinating rescue work, and that Tijerina had told him there were at least 100 miners still trapped in one shaft.

Police officials at the scene said they believed that sparks from a faulty power generator may have come into contact with coal gas and caused the explosion at "Cuatro

y medio" mine.

The underground mine, the main shaft half a mile long, is located two miles from La Esperanza, in Coahuila state, 70 miles southwest of Eagle Pass, Texas.

The mine belongs to Compania Hulera Mexicana, but a telephone operator at the main office in Mexico City, who did not identify herself, said they could not get in contact with mine office in La Esperanza.

"The telephone there has apparently been damaged by the explosion," she said.

Egyptian proposal divides Israel; soldiers force Arab shops open

JERUSALEM (AP) — Israel's coalition government was split Monday over an Egyptian peace proposal that includes suspending Palestinian riots and a moratorium on Jewish settlement in the occupied territories.

Reporters saw soldiers use sledgehammers and crowbars to open shops in Gaza City and the West Bank to try to end a lingering strike of Arab merchants.

Four Palestinian activists from Gaza facing deportation dropped their appeals to Israel's Supreme Court on Monday.

"They feel they will not obtain justice from an Israeli court," said Fayeze Abu Rahme, a Gaza lawyer. "They said international public opinion has already decided that deportation is illegal and we'd hate to see it legalized in court."

Four Palestinians from the West Bank were expelled to Lebanon on Jan. 13. A fifth West Bank Palestinian dropped his appeal earlier this month.

American Jewish leaders condemned the beating of rioters.

Hundreds rally in support of police after vagrant shoots Dallas officer

DALLAS (AP) — Hundreds of people rallied to support the beleaguered Police Department on Monday as authorities said they would try to prosecute bystanders who yelled "Shoot him, shoot him" before a vagrant killed a police officer.

"It's good to see this support in the community for a change. Most of the time we only see the negative side," said officer Thomas Cicio, observing the crowd of about 400 who marched from the John F. Kennedy Memorial to City Hall and back.

The shooting of the white officer by the black vagrant Saturday has heightened a growing tension between the mostly white department and the city's minority community, whose leaders have criticized the department for several police shootings of blacks.

Meanwhile, police Capt. John Holt said officers were trying to identify the two to 10 onlookers who, according to witnesses, yelled "Shoot him, shoot him," encouraging the vagrant to shoot officer John Chase after he took Chase's revolver.

Nelson urged to recommend paid MLK holiday

The ASU Faculty Senate suspended normal procedure Monday to overwhelmingly pass a resolution urging ASU President J. Russell Nelson to recommend that the Arizona Board of Regents enact a paid University holiday honoring Dr. Martin Luther King Jr.

Only three professors dissented against the resolution, which history Professor V.P. Franklin introduced. Normal procedure was suspended so the issue could be voted on immediately, rather than face the usual one-month delay period, prior to action.

Bruce Mason, a former senate chair, introduced a similar King resolution last year. He said he thought Nelson would support the holiday if either of the other university presidents did.

"I don't think you're going to get two of them to vote one way and one, another. I think they're all going to vote together," Mason said.

Nelson later said the council of presidents, comprised of the three Arizona university presidents, have considered the King holiday previously, but had not yet decided what position to take.

"The council is trying to evolve a way to proceed, and we haven't done that yet," Nelson said. "We may decide we don't want to do it as a joint proposal; we may decide we do. We just haven't reached a conclusion on that at this time."

Nelson added, "I will certainly share the recommendation that came out of the senate with my colleagues and it will become, I have no doubt, part of the discussion."

Franklin's resolution urged Nelson's support to the regents, rather than Nelson taking action himself, because Arizona Attorney General Bob Corbin ruled in October that university presidents do not have the right to declare university holidays.

After the ASU American Federation of Teachers and Union Employees requested the board to consider the paid state King holiday, regent executive officer Molly Broad was the first to react.

Broad responded, "The approval of specific university holidays will not be considered by the board until a subsequent meeting and only after recommendations have been received from each university president (or a single recommendation from the presidents collectively). . ."

Franklin submitted the resolution at the Jan. 15 meeting of the regents.

Franklin said it is important for the universities to set an example for the state by instating the paid King holiday. "It seems to me that education has a responsibility to serve as a model of practice to the citizens."

Franklin said it reflects poorly on the state not to have accepted a holiday that more than 40 other states already have acknowledged was "the right thing to do."

Mason said that even if the presidents recommend the resolution, passage will not necessarily be merely a formality. "I would say the odds are better than zero, but I wouldn't say they're 100 percent," Mason said.

The King resolution was only the second motion to bypass normal senate procedure this year. (The other special resolution was a commendation of former faculty athletic representative Marianne Jennings.)

Franklin said he was "very" surprised his resolution passed Monday under the special motion, but he added, "There were a lot of senators here who have been very supportive of the resolution, and they were instrumental in getting it passed."

Next month's faculty senate meeting will include a panel discussion on the role of academics in athletics at ASU. Featured panelists will include Nelson, athletic director Charles Harris and faculty athletic representative Jerry Kingston.

Liberal Arts dean finalist for UTEP presidency

ASU College of Liberal Arts Dean Samuel Kirkpatrick has been named as one of six finalists for the presidency at the University of Texas at El Paso, according to sources close to the selection committee.

Judson Williams, former El Paso mayor and a member of the selection committee, confirmed to an El Paso newspaper that Kirkpatrick was on the list.

Kirkpatrick, 45, who has been at ASU since 1984, earns \$89,320 a year as dean of

the College of Liberal Arts and Sciences.

But Kirkpatrick said Monday afternoon, "I am not at this stage interested in that, and to the best of my knowledge I am not a finalist."

University of Texas officials are looking for a replacement for Haskell Monroe, who left UTEP in May to become chancellor of the University of Missouri Columbia.

Kirkpatrick, who received a Ph.D. from Penn State University in 1969, was head of the political science department at Texas A & M from 1977 to 1984. He was director of the Bureau of Government Resources at the

University of Oklahoma between 1969 and 1977.

Other candidates for the post include: Bryan Amacher, dean of the College of Commerce and Industry at Clemson University; Robert L. Lineberry, dean of the College of Liberal Arts at University of Kansas; John Michael Palms, vice president of academic affairs at Emory University; Diana Natalicio, UTEP's interim president and vice president of academic affairs; and Gerry Meisels, dean of the College of Arts and Sciences at University of Nebraska at Lincoln.

Construction nightmare costs University big bucks

"Wait a minute!" I yelled after being hit with a sudden thought. They both turned slowly back toward me.

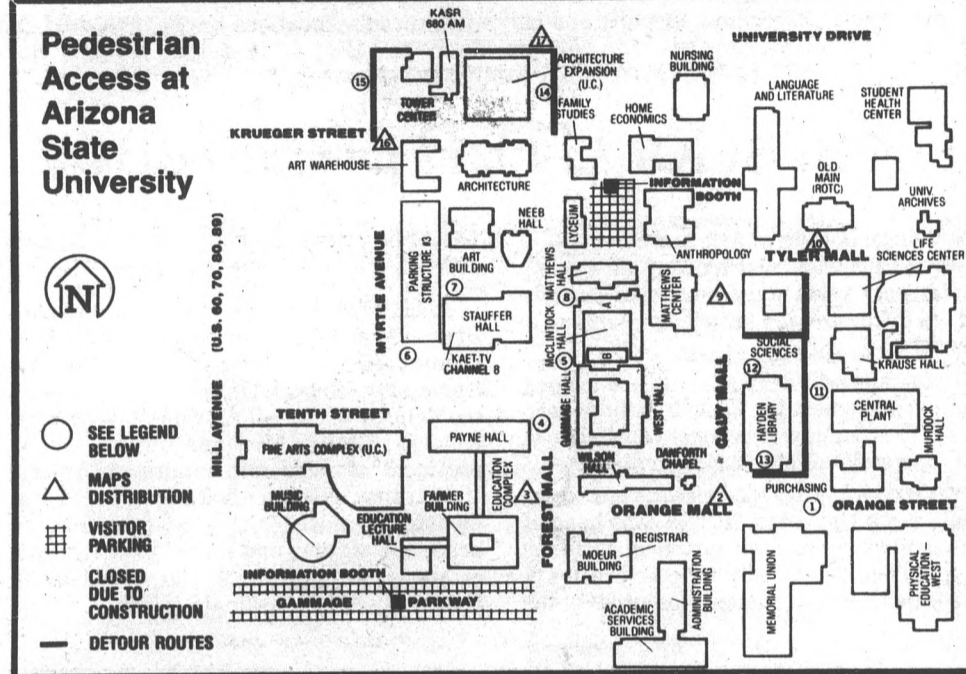
"I just remembered," I said. "It's getting to be 11 o'clock. Nelson is probably out to lunch."

Placing the blame

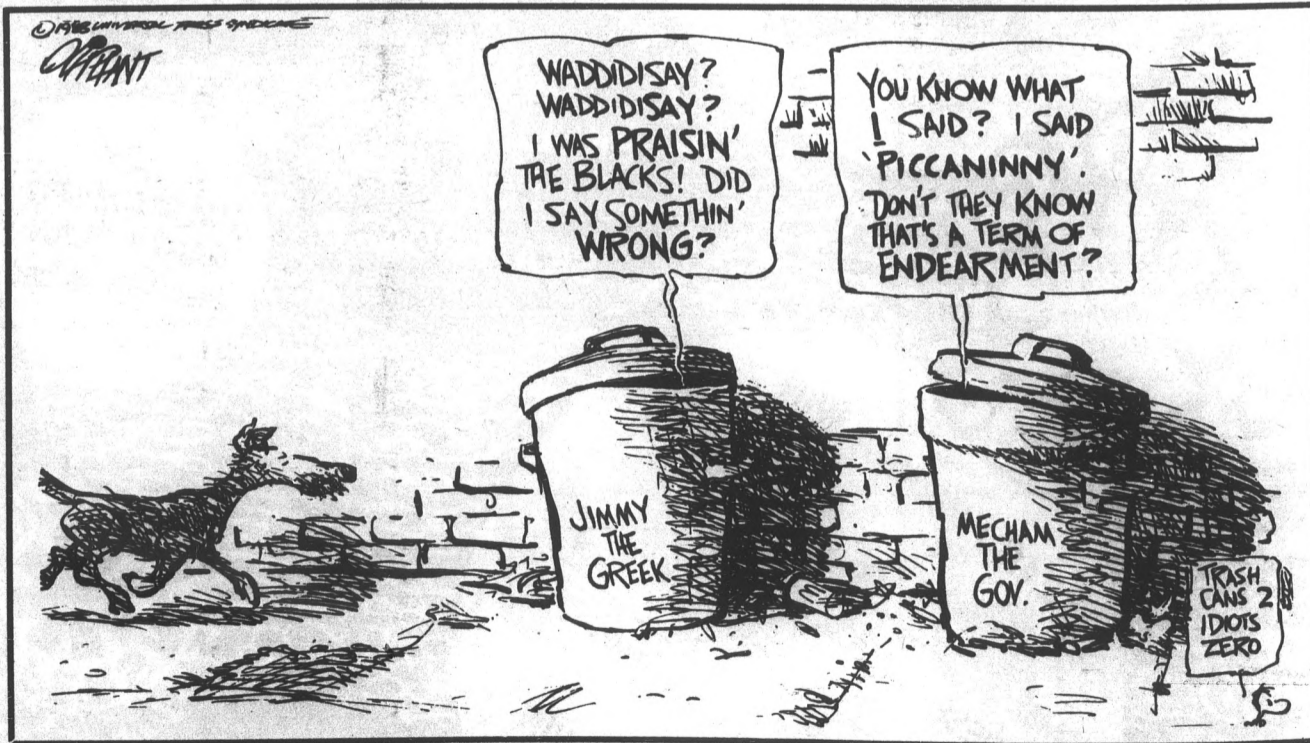
I wasn't surprised that the recent editorial by Ed Schubert (Inevitable Conflict, Jan. 20) was full of half-truths and misinformation, but I feel I must respond. First of all, Mr. Schubert acts as if there is no reason for the recent unrest in the occupied territories. He and I both know that Palestinians in the occupied territories are denied even the most basic freedoms, such as the right to free speech.

Then Schubert wants us to believe that Israel doesn't want the occupied territories. If this is true, why does Israel refuse to even begin negotiations in a "Land for Peace" deal? And while it is true that Israel is a democracy, it is only a democracy within the 1948 borders. The Palestinians cannot elect members to the Israeli Knesset, and those who try to practice free speech run the risk of jail time.

Mr. Schubert asks why Palestinian struggle has always been violent. It hasn't. Some who have tried non-violence have had very little success for a couple of reasons. With the unjust criminal "justice" system in the occupied territories, citizens have no retribution against government policy. And with no voting rights, two traditional and effective avenues of bringing about non-violent change are closed to the Palestinians. In addition, Israel has a policy of jailing or deporting leaders in the community. This makes it impossible to build the kind of organization needed for effective mass civil disobedience.

With regard to the Palestinians, Mr. Schubert blames the oppressed for the oppression. I wonder if he blames the black South Africans for apartheid or the Jews for the Holocaust.

Embarrassed silence is a healthy political symptom

WASHINGTON — The pair of political debates last weekend — the Democrats in Des Moines and the Republicans in Hanover, N.H. — proved once again that silence is golden. They produced some of the toughest exchanges and most spirited quarrels of the young campaign season.

But all the sound and fury were less striking than two stunning moments when nothing could be heard.

One came early in the *Des Moines Register* debate, when editor James Gannon asked Gary Hart if he thought he had disposed of the "character question" by suggesting in an interview with Gannon's paper that if elected, "I would not be the first adulterer in the White House."

Hart replied that he had meant the remark simply as a reminder that "all of us are sinners. The question is whether that disqualifies us. There is another level of morality at stake here. This administration has been bankrupt in its commitment to public ethics. I would never lie to Congress. I would never shred documents. I would

never sell arms to terrorists."

When Hart had finished this self-serving declaration, he looked expectantly into the Civic Center audience for affirmation. What he heard was a thundering silence that could be felt halfway across the country in Cambridge, where I was watching on television.

The Iowans were simply not persuaded that anyone who promised only to exceed the standards set by the worst fools and knaves in the Reagan administration passed muster for the presidency. By their refusal to give Hart a single handclap, the good people of Des Moines were telling him that he would be judged by their exacting standards, not by lowest-common-denominator political morality.

The next afternoon at Dartmouth, NBC's John Chancellor, who is so gifted a discussion leader he should be drafted for permanent duty in the debates, produced another remarkable silence by asking one of those questions only he seems ready to utter.

The candidates had been going on about their plans to combat drugs, bragging how they were going to get tough on the pushers, on the overseas growers or maybe even deny drivers licenses to users who flunk random drug tests. They had all recited their standard position-paper prose on the subject and seemed ready to move on to the

next set of staff-created, pollster-tested cliches, when Chancellor begged to ask one question of his own.

In New York, he said, and in other cities, the drug rehabilitation centers are so overcrowded, so short of staff and facilities, that kids who are trying to break their drug habits find themselves standing in line or being turned away when they seek help. What are you going to do for those who have found the courage to say no, he asked, but who need professional help to make their vow stick and to get their lives back under control?

Chancellor threw out the question to the six Republican candidates, and there was a long moment when they eyed each other, waiting for someone to pick up the challenge. That silence continued just long enough for everyone in the auditorium to become acutely aware of the discomfort the Republicans were feeling. And then Bob Dole spoke. "It's going to take money," he said.

Just five words, but they were as welcome as a cup of coffee after a long hike in the chilly woods around Hanover. The applause that greeted Dole's extended answer signaled the audience's gratitude for his candor.

The silence that Hart encountered in Des Moines and the silence that Dole broke in Hanover are symptoms of something very

healthy in the climate of this election year.

After all the shocks of 1987 — the Iran-contra story, Jim and Tammy Bakker, Gary Hart and Joe Biden, the Wall Street insider-traders and the rest — there is an understandable upsurge of cynicism among the voters. They have real concerns about the future of their children and their country. But understandably many of the voters I have met doubt whether the power seekers and the power brokers are prepared to deal seriously with those questions.

When Gannon and Chancellor, two of the best journalists in the land, confronted candidates with some of that reality, the reaction was revealing — and reassuring. Hart learned in Des Moines how little tolerance there is for his rationalizations. The voters have learned that a man who can't get his own identity straightened out is not likely to straighten out the country's problems.

In Hanover, Chancellor challenged all the Republicans to acknowledge another reality: that good intentions and strong principles are not enough. When people are in trouble, they need help, and often giving them that help costs the government money. When Dole acknowledged that bit of reality, he not only aided his campaign, he struck a blow against the cynicism that's out there. More debates, more silences, could cure the cynicism.

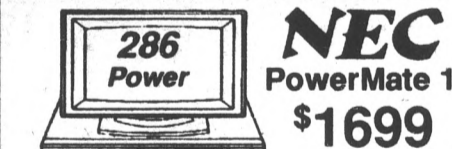

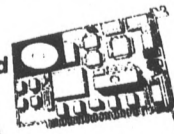

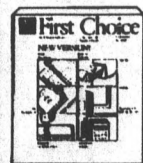

Tempe crime down 3 percent; rape, assault reports increase

Crime reported to Tempe police in 1987 dropped 3 percent, but the year set records for rapes, larcenies and auto thefts, according to police records.

The number of reported rapes, 82, escalated 38 percent in 1987. Larcenies were up 3 percent and auto theft rose 5 percent.

Police attribute the record number of rapes to the city's 6 percent increase in population and to the rise in the number of rapes reported.

In 1987, almost one person out of 10 fell victim to some type of crime, according to records.

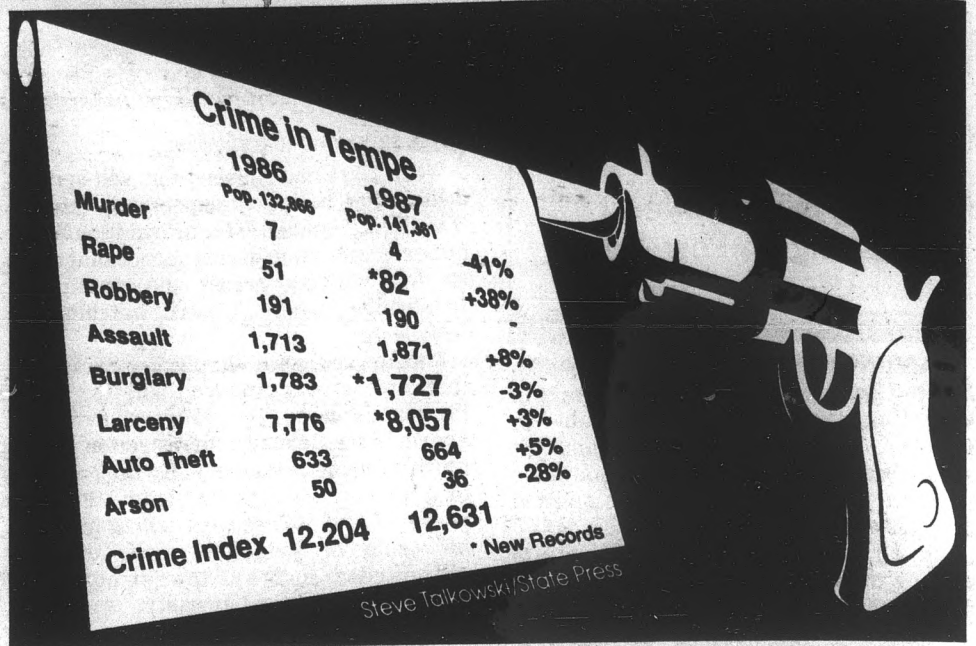
According to records, assaults were also up. ASU students are considered contributing factors, both as perpetrators and victims, said police spokesman Officer Roger Austin.

"Because of ASU, we have an unusually high younger population," Austin said. "Consequently we have more violent crimes because of the younger population."

Most students fall into the 18- to 25-year-old category, the largest age group for victims and those who commit crimes.

Austin said most violent crimes occur on weekend nights.

The crimes with the biggest drop were murder, 41 percent, and arson, 28 percent.



Statistics show increase in number of car accidents in 1987

The number of car accidents in Tempe during 1987, including fatal ones, were up, according to police records.

In 1987, according to records, there were 2,561 accidents involving injuries — a 6 percent increase from the previous year.

Fatalities increased from 18 to 21 in 1987, while non-injury accidents were down 1 percent.

Police said the increase in accidents comes from Tempe's rapidly growing population.

"There is really not an increase (in accidents) in my mind," said Sgt. Loren Wunderle, a five-year veteran of the Tempe police traffic bureau. "There are more riders, so naturally accidents are going up."

"Alcohol has a great deal to do with our fatal accidents," Wunderle said.

He said the traffic bureau is currently working on its 1987 traffic fatality study, but in the past two years the department's study has shown that alcohol has been involved in half the fatal accidents.

Police say the deadliest intersection in Tempe last year

was McClintock Drive and Don Carlos Avenue, where three accidents claimed four lives.

"In past years the Rural Road and University Drive intersection was considered the most dangerous," said Officer Roger Austin, police spokesman. "This past year the area was McClintock and Don Carlos."

Accident rates involving cars and pedestrians or bike riders were not significantly changed from last year.

Wunderle said locations like University and Hohokam Drives, usually high accident centers, are declining, while accidents on West Baseline Road are on the rise.

Reading-exam results delayed by U.S. agency

WASHINGTON (AP) — A government-backed testing agency delayed release of 1986 reading-exam results because scores among nine and 17-year-olds dropped sharply, and embarrassed officials suspect testing procedures, not students' reading abilities, may have slumped.

The drop was in the reading portion of the National Assessment of Educational Progress, an exam given to 70,000 students ages 9, 13 and 17 selected to represent their entire age group. Scores for 13-year-olds did not fall.

The assessment, calling itself "the nation's report card," is run under a \$4 million-a-year federal contract by Educational Testing Service of Lawrence Township, N.J.

"We have, it's embarrassing to say, a real mystery here. We haven't come up with any ideas that solve the problem," Archie E. Lapointe, executive director of the testing program, said Monday in a telephone interview from ETS headquarters.

Lapointe called it "an incredible, unbelievable loss," and said flatly, "We don't believe the data."

"If we were to accept that data, it would look as though kids have lost a year or more's performance . . . from 1984," said Lapointe. "It's such a sharp loss that had it occurred, just about every teacher of those youngsters in the country would have perceived (it)."

East 57th Street heads list of expensive streets

NEW YORK (AP) — East 57th Street edges out Tokyo's Ginza and a neighboring stretch of Fifth Avenue as the world's most expensive street, according to a rental survey released Monday.

The survey, which charted ground-floor retail rents, found that the average rate on East 57th is \$425 per square foot, compared to \$375 on Fifth between 52nd and 58th streets. Retail rents on the Ginza average \$400 a square foot.

Last year, in a survey of American shopping streets,

Fifth Avenue came out on top. Michael Hirschfeld, whose real estate firm compiled the survey, said the shift was attributable to new space coming on the market on East 57th and construction which has tied up some space on Fifth.

Rounding out the top 10 were: Madison Avenue between 60th and 79th streets in New York; Rodeo Drive in Beverly Hills, Calif.; Michigan Avenue in Chicago; Bond Street in London; Worth Avenue in Palm Beach, Fla.; Rue de Faubourg St., Honore, Paris; and Bloor Street, Toronto.

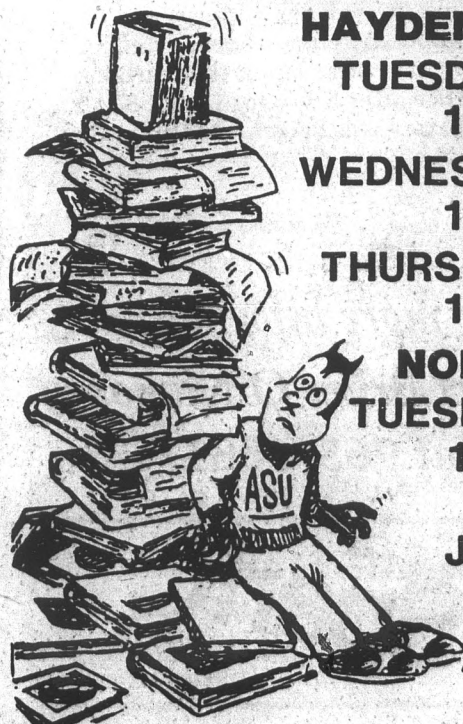

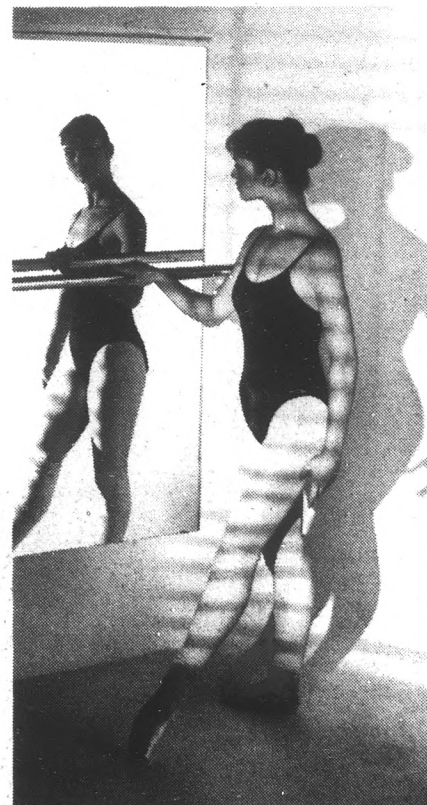

Tempe man arrested after allegedly robbing bank

A 34-year-old Tempe man, wanted for questioning in connection with seven robberies in Tempe and nine others throughout the Valley, was arrested Monday after he allegedly robbed a Mesa bank, police said.

When a police cruiser pulled up behind the car, he jumped out of the car, ran through a residential area where he was caught by officers with their guns drawn as he came through a yard near Sixth Place and Center Street, Hayes said.

Field of candidates in Tempe City Council election grows

Campbell, Williams put names on ballot for seats on Tempe City Council

Two more Tempe residents joined the race for the Tempe City Council Friday, increasing the field of candidates from five to seven.

Vivienne Campbell and Prentice Williams joined incumbents Don Cassano, Patricia Hatton and William Ream, and newcomers Rick Goodwin and Barbara Sherman in the race to capture one of three available council seats.

Incumbent Harry Mitchell will run unopposed in his bid for a sixth term as mayor as no other candidate filed a nomination petition for the office before the Friday, Jan. 22 deadline.

Mitchell, a government teacher at Tempe High School, has been mayor for the last 10

years.

The seven city council candidates are competing for four-year terms on three of the council's six seats. The seats of Vice Mayor Frank Plencner, Councilman Rowland Oonk and Councilman Carol Smith are not up for election until 1990.

The primary election for the seats will be held on March 22. Any candidate who captures 50 percent or more of the votes will win one of the seats. If any seats are left open, the candidates will run in a general election to be held May 10.

Both Campbell, an accountant, and Williams are running for their first terms on the council.

Cassano, a Tempe businessman, is running for his second consecutive term, having been first elected in 1984.

Realtor Rick Goodwin, a member of the Tempe Chamber of Commerce's Economic Development Committee, is running for his first term.

Hatton has been a member of the city council since 1976 and is running for her third term.

Ream, a former Tempe businessman, is the longest veteran of the council, having served three consecutive terms since 1972.

Sherman, a self-described “community activist,” is running for her first term.

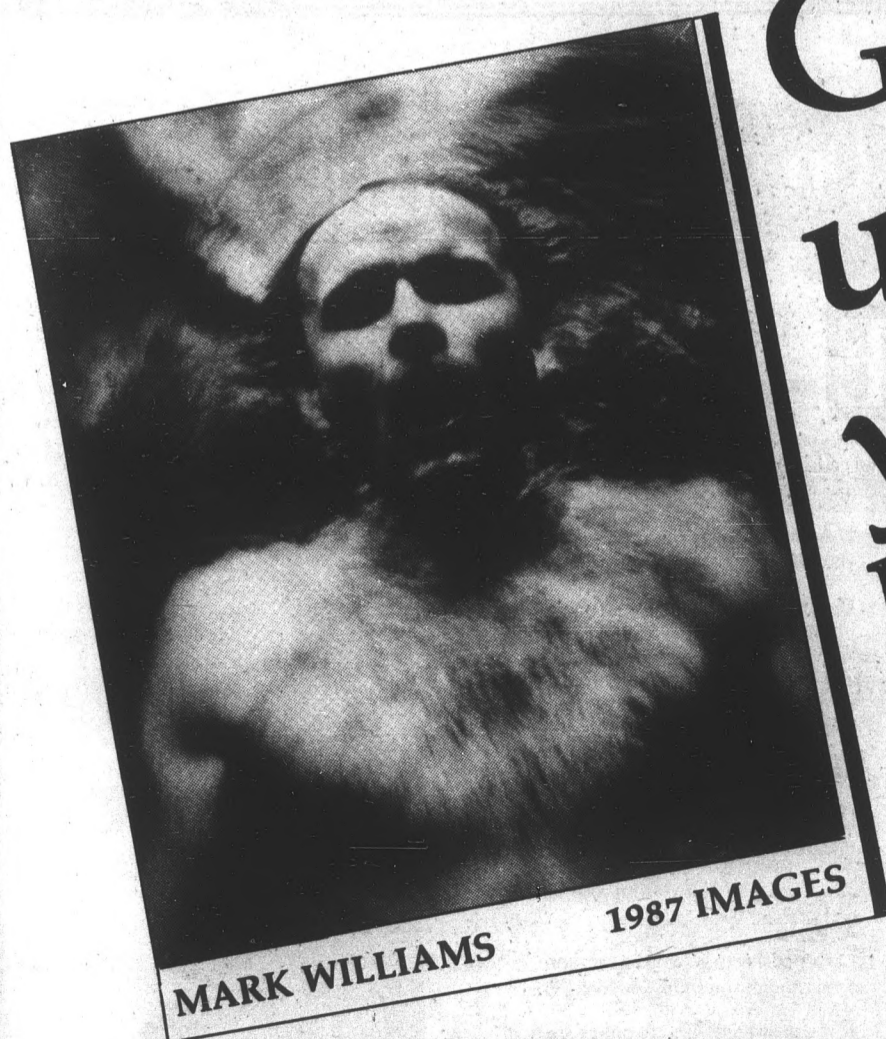
Each candidate needed at least 278 valid signatures on their nomination petitions to be placed on the ballot for the primary election.

But Lee said: "I must differ in recollection from Mr. Schwartz. I can't come to the same quick and easy conclusion as he does."

He said the group never discussed or decided if the fund was public money.

Lee said he had no prior knowledge of Mecham's intent to use the fund and that he never would have approved an \$80,000 loan to a business that the governor controlled.

The committee also received the final piece of evidence in its investigation into alleged death threats made by former Mecham aide Lee Watkins against Donna Carlson and Mecham's alleged attempt to block an attorney general's investigation into the threats.

Peggy Griffith, to whom Watkins communicated the threats against Carlson, said in a sworn written statement that Watkins also issued a stern warning to state Republican party chairman Burt Kruglick and former GOP chairman Tom Pappas to "keep their damn mouths shut."

Griffith said she believed the "threats to be real."

According to Griffith's statement, Watkins was angered by Carlson's testimony before a state grand jury investigating Mecham's failure to disclose a \$350,000 loan from Tempe developer Barry Wolfson.

Griffith quoted Watkins as saying,

"Donna will take a long boat ride and never come back."

Griffith added that Watkins told her to remember that their conversation "never happened."

Watkins also alleged that Kruglick and Pappas knew of the Wolfson loan for months. She quoted him as saying, "Who in the hell do they think they are, the god damn liars."

Griffith added that she believes Mecham would have handled the Watkins matter properly had he been better advised by Department of Administration Chief Max Hawkins.

Skelly, R-Scottsdale, said both parties agreed that the protocol fund contained state funds when they determined that the money would only be used for promoting state interests.

He said Colter will not be able to testify on the protocol fund because he doubts Colter will return before the committee finishes its business.

The committee will resume testimony today at 7 p.m. Woods will continue his testimony and then the committee will move onto Mecham's handling of the Wolfson loan. Mecham is expected to testify later this week.

Meanwhile, Secretary of State Rose Mofford certified 301,032 recall signatures Monday, more than 80,000 in excess of the number needed to mandate a recall election.

Garrett added that before Babbitt purchased the list the campaign was told by Iowa Democratic Party lawyers that using personal contributions would be appropriate.

But Phil Roeder, a spokesman for the Iowa Democratic Party, said the only legal opinion issued in the matter was when party lawyers said it was OK for the party to accept payments from the candidates.

Roeder added that if the FEC were to rule that the contributions violated the law, Babbitt may be forced to refund the \$5,000 to Stephan.

FEC spokesman Fred Eiland declined comment on the investigation, saying that all FEC matters are confidential until a final report is issued.

Eiland said the FEC decides to investigate when a complaint is filed, when the commission has indication of

wrongdoing or when the U.S. Justice Department asks for an investigation.

On Sunday, the Associated Press reported that Eiland said: "Anything of value represents a contribution which must be reported... They have given something of value to a candidate and it must be accounted for. Without the \$10,000, the list would not have been provided."

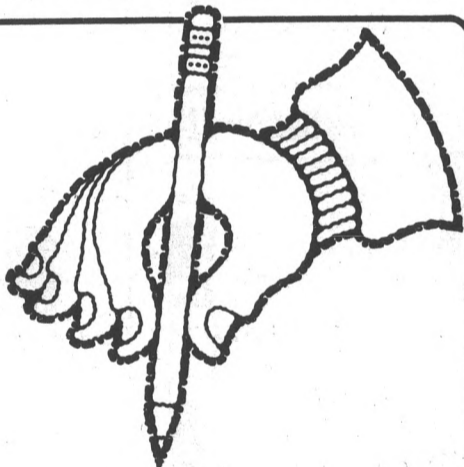
Babbitt's campaign has been put on hold this week as the candidate returns to Arizona following the death Sunday of his

89-year-old father, Paul Babbitt Sr.

The handling of the lists come at a time when former Colorado Sen. Gary Hart is under scrutiny from FEC officials for his dealing with video producer Stuart Karl in both the 1984 and 1988 campaigns.

The Miami Herald reported last week that Karl chauffeured Hart in jets and helicopters, paid a \$3,000 monthly salary to a campaign aide and paid other travel expenses in the 1984 campaign.

ASU wrestlers fall to top-ranked Cowboys

A successful roadtrip to the Midwest still saw the ASU wrestling team slip on its climb to the top of the ladder.

The Sun Devils improved their record to 11-2, but will not jump in the new polls due to a 22-16 loss to Oklahoma State, the nation's No. 1 team.

ASU rattled off three straight dual wins over Oklahoma, 27-14, Boise State, 28-20, and Nebraska, 40-6, before being defeated by the Cowboys.

But the weekend trip will help Coach Bobby Douglas' squad gear up for two Pac-10 contests with Oregon and Oregon State, Jan. 28th and 29th. The Sun Devils will take part in the Oregon Wrestling Classic Jan. 30 which matches ASU against several conference opponents.

In Pac-10 dual meets the Sun Devils are 1-0 with a 45-2 win over Fresno State.

ASU fell behind early in the match with the Cowboys after 188-pounder Zeke Jones dropped an 8-6 decision to Cory Baze. Prior to the match Jones was undefeated.

But Chip Park (126 pounds) had his eye on aiding his team in bringing the top national ranking back to Tempe. After three periods of wrestling, Park prevailed over Kendall Cross, 12-7.

This tied the match at 3-3, and Oklahoma State went on to win the next four weight classes to pull out to a 19-3 advantage.

Sun Devil Jim Gressly (167 pounds) gave his team three points to cut the deficit to 19-6 after defeating Mike Farrell, 13-8.

But trying to gain momentum was not a successful chore. One weight class later, John Ginther (177 pounds) dropped an 8-3 decision to Chris Barnes.

This gave Oklahoma State 22 points ending its final tally. ASU received its usual strong production out of upper weight divisions. Mike Davies and Rod Severn picked up victories by the score of 12-5 and disqualification, respectively.

However, the two wins would not be enough for the Sun Devils, who lost only their second dual meet this season.

Before returning home ASU made a stop in Albuquerque,

New Mexico, to wrestle the Lobos.

It would be no contest as the Sun Devils downed New Mexico, 40-9.

The Lobos were able to muster only one win for the day. Greg Gascon, the 11th-ranked 118-pounder, upset Jones (17-2-1), who is currently in fourth place, 10-9.

New Mexico scored six points after the Sun Devils had to forfeit the 134-pound division.

ASU had victories from Park (15-4), Jim Sinadinis (142 pounds, 7-5), Tommy Ortiz (150 pounds, 17-7), Dan St. John (158 pounds, 22-2-1), Gressly (20-5-1), Ginther (19-4) and

Davies (22-1).

Severn, a senior, remains the Sun Devils lone unbeaten wrestler with a 14-0-3 record.

Davies moved into second place on ASU's all-time victory list with his five wins over the weekend. He is nine wins shy of Dan Severn's record of 127 wins.

The senior from Chardon, Ohio, will represent ASU Feb. 2nd in Cedar Rapids, Iowa, when he wrestles in the NWCA All-Star Classic. Davies will be matched against Eric Voekler of Iowa State. The pair have wrestled twice this season, with each winning a match.

Women gymnasts defeat Wildcats, remain undefeated

Striving to attain its goal of a national championship, the ASU women's gymnastics team remains undefeated after three victories in a weekend match.

ASU's score of 185.95 was 30 points better than UA and easily topped the tallies of Oklahoma and Wisconsin in last Friday's Cactus Classic in Tucson. The wins boosted the Sun Devils' record to 4-0.

This year's team consists of mostly sophomores and juniors, and relies on the talents of All-Americans Karli Urban and Suzy Baldock.

"They're both all-arounders," assistant coach Lisa Zeis said, pointing out that both gymnasts compete in all four events. "They're not just the top gymnasts at ASU, but in the nation too."

"They are very consistent and both have great attitudes — you need that on a team."

"We're better than last year at this time,"

ASU sophomore Suzy Baldock said. "We're more mature and know what to expect."

"It's really good that our freshman (Michelle Colavin) is hitting."

"Last year there were five freshmen competing," Zeis said. "Now as sophomores they know what to expect at meets, and know what to do."

The Devils are hoping to top last year's fifth-place national finish, and the win over UA keeps them at a good pace.

"UA is always tough — it was a big win for us, especially with them being at home," Zeis said. "Our score of 185.95 is really good. So far, everything is looking good."

"We want to enter nationals with a higher score to make the latter section," Baldock said. "If you do, you have a better chance of winning."

Twelve teams make it to nationals. The bottom six are in the first section and usually receive lower scores by the judges. The top six teams go in the second rotation

and have a better chance of winning the championship.

Zeis said that the better teams compete in the top rotation, and everyone tries harder. Also, the judges are more lenient, she said.

ASU will be up against tough competition when they play host to Utah, Utah State and Washington at 7:30 p.m. on Friday in the Activity Center.

"Utah is bringing their alumni to cheer them on," Baldock said. "We beat them here last year."

Zeis said the Devils are, purposely, slowly improving week by week so they reach their peak at nationals.

"We threw in more difficulty at U of A," Zeis said. "Against Utah we're not going to do anything new. We want to perform consistently and don't want to introduce anything risky."

"We upgrade until we feel comfortable and then upgrade again," she said. "We're going to keep working our way up to reach

our peak."

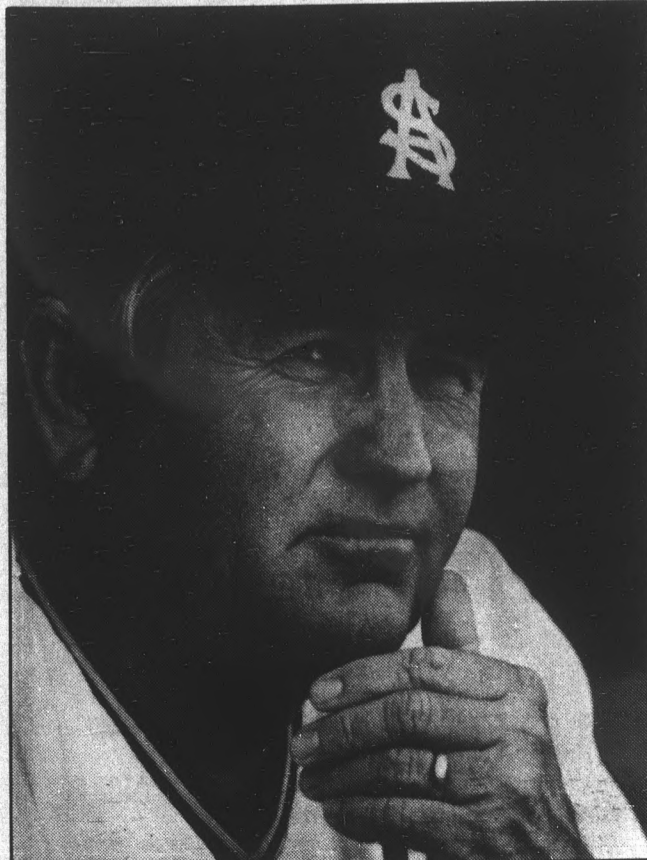
Although ASU has All-Americans and rising stars on the team, none of the gymnasts have Olympic dreams.

"Usually, gymnasts go for the Olympics before they compete at the collegiate level," Zeis said. "By the time they compete in college, they're pretty much done."

Most gymnasts use their talents to help obtain a college education, but it is another life after gymnastics, Zeis said. After that, they just keep in shape through running and aerobics, she said.

"I'm just glad that I'm getting out of the sport," Baldock said. "Not right now, but soon."

The girls in gymnastics are getting smaller and are doing more difficult moves, she said. To compensate for this, measures are being taken to make routines more difficult.

Brock uses time off to work on basics

On the surface, the Sun Devil baseball team is perfect. It's hard to argue with a 3-0 record. But it's a long way to the College World Series in Omaha, and coach Jim Brock knows there is work to be done.

The Devils are idle until Friday, when Cal-Riverside comes to Packard. Usually when the season begins, the game days just keep coming and practice time is cut down significantly. But a strange twist in this year's schedule has allowed Brock the luxury of time.

"This is an excellent situation," Brock said. "We should be able to set up practices next week where we'll be able to come up with some quality work on those areas where we need it."

Brock said those areas include base running, stealing, keeping the opposition from stealing and relays.

For example, a mix-up on a relay resulted in two unearned runs during Thursday's game. Over the three games, the Gauchos also stole 12 bases in 13 attempts.

The Devil defense, which looked anemic on Thursday when it committed five errors, improved as the weekend progressed.

"I think we got those first-game jitters out of the way," second baseman Kevin Higgins said. "Now it's just time to play baseball."

The pitching appeared deep enough to drown many opponents. Linty Ingram pitched nine innings and Kurt Dempster completed five. Brian Dodd got into the seventh inning of his start. Rob Mattson and Blas Minor looked strong

out of the bullpen. With conference play right around the corner, Brock is "thoroughly pleased" with the pitching.

"If we can play defense," Brock said, "the pitching that we think we have should keep us in most ballgames."

ASU collected 36 hits and 27 walks in the three ballgames. Not a bad average.

Although the walks are mainly gifts from the other team, Brock wants the Devils to take some credit.

"We seem to have pretty good judgment on strikes and balls," Brock said. "We don't seem to swing at a lot of bad pitches, which at this time of year sometimes you will."

The Sun Devils hit three home runs in the opening series, but Brock is not from the Earl Weaver School. He cannot afford to sit back and wait for the three-run homer.

"I don't think we're going to hit that many home runs," Brock said. "We're going to have to get the walks when they're there, steal the bases, hit-and-run, take the extra base. These are the kinds of things this ballclub has to do."

The Devils will play host to Cal-Riverside for a two-game series beginning at 2:30 p.m. Friday.

Track star honored by AP

NEW YORK (AP) — Track and field star Jackie Joyner-Kersey, Associated Press Female Athlete of the Year for 1987, is familiar with the great career of Babe Didrickson Zaharias, with whom she is compared.

"I saw her story on TV," Joyner-Kersey said. "She inspired me."

"It was touching to see her (high) jump into sawdust. And to watch her play golf and tennis."

"Her being a woman, and being so dedicated in what she wanted to do was inspiring."

Joyner-Kersey, the world record-holder in the heptathlon, co-world record holder in the long jump and a former basketball star at UCLA, is considered the finest all-around woman athlete in the world today.

This year, Joyner-Kersey, 25, will try and match the Babe's two Olympic golds in the Seoul Games — in the heptathlon and long jump.

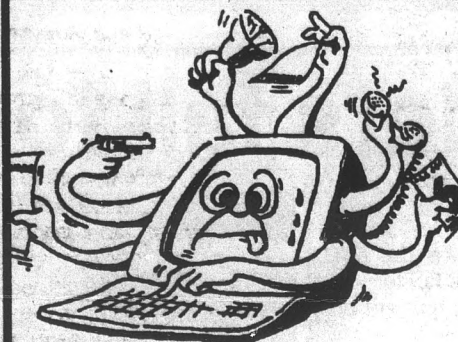
Her accomplishments in those events, along with outstanding performances in the high hurdles, helped Joyner-Kersey win the 1987 Female Athlete of the Year Award Monday.

In balloting by a nationwide panel of 244 sports writers and broadcasters, she received 128 first-place votes, 68 seconds and 16 thirds and a total of 880 points, with points allotted on a 5-3-1 basis.

West German Steffi Graf, the world's top-ranked woman tennis player and winner of 75 of 77 matches, including the French Open, finished second in the balloting with 806 points.

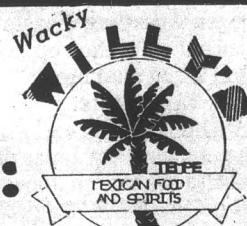

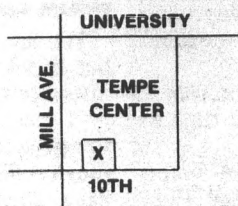

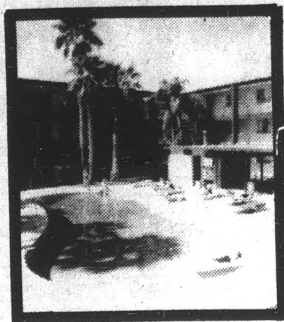

Despite what looked like traumatic losses this weekend, the ASU swimming and diving teams are feeling positive and gearing up for their upcoming match with UCLA.

ASU lost to California, 83-30, on Saturday and to Stanford, 80-33, on Sunday. While the losses looked bad on paper, ASU coach Ron Johnson said ASU was more competitive than the scores indicate.

"We lost a lot of close races," Johnson said. "But you don't get points for almost winning."

ASU sophomore Paul Howe had career-best unshaved times in the 200 meter and 500-meter freestyle. Swimmers usually shave their bodies only at the end of the season for national championships, when times are crucial and tenths of a second could mean the difference between first and second place.

Johnson said Stanford and Cal were strong and ready for ASU. He cited the fact that these were their first major competitions of the year and that ASU was coming off of a hard week of practice.

"We had good times considering this stage of our training," Johnson said. "They were just real ready for us."

Stanford coach Skip Kenney said his team had a good meet, but noted only four team highlights. Kenney said ASU had a fine performance and that the times between the two teams were close.

"We swam well, but not great," Kenney said. "ASU really competed well. Ron Johnson does a good job with his teams."

Johnson said the team knew the meets would be difficult and the loss did not adversely affect them. He said he just wanted the best efforts out of the team and told them not to worry about the results.

Nort Thornton, Cal's swim coach, said his team had an exceptional meet and is looking forward to the national championships. He also said the results of the meet did not really reflect how well ASU swam.

"ASU swam pretty fast," Thornton said. "The scores were not indicative of their performance."

Although two marks in the win column would have been nice, Johnson said the intense training will benefit the team and that they are still in good shape and looking forward to the meet with UCLA.

"The solid week of training will pay off down the line," Johnson said. "It is far more important how you do at the end of the season."

Bowl-bound '3 Amigos' key to Elway's success

SAN DIEGO (AP) — At Seaport Village, about 200 paces down from the Super Bowl headquarters hotel, there is a group of souvenir shops, one of which allows tourists to pose with a cut-out of their favorite celebrity.

Ronald Reagan is there, and so is Tom Selleck, but there's also a sign advertising the availability of the NFL's latest celebrities — the Three Amigos.

It's a symbol the world is beginning to recognize: There are other guys on the Denver Broncos besides John Elway. It's also a symbol of how the NFL world has turned. Of the six top wide receivers in next Sunday's Super Bowl, only 6-foot-3, 210-pound Art Monk has the size that used to be required for an NFL receiver.

Monday was the first official day of Super Bowl week with Denver arriving during the afternoon. The Washington Redskins arrived Sunday night and were immediately jolted by an earthquake at 5:15 a.m., centered about 75 miles from here in Mexico.

One member of the Redskins entourage said it felt like Wally Kleine, a 6-foot-9, 345-pound rookie, fell out of bed. And on to the Three Amigos — Vance Johnson, 5-11, 174 pounds, in his third year; Mark Jackson, 5-9, 174, in his second, and Ricky Nattiel, 5-9, 180, this year's top draft pick. They scoot in, out and around defensive backs while Elway gives them time to get open with his almost unstoppable scrambles.

They have moved Steve Watson, 6-4, 195 and a nine-year veteran, to the shadows. The 30-year-old Watson was splitting time with Jackson until he broke six ribs in a replacement game against the Raiders Oct. 12. That ended a string of 123 straight games.

"At that point," Watson says, "the Three Amigos emerged, and I became the Gringo."

With Elway having his best season, Johnson caught 42 passes in the 12-game season played by the regulars, Nattiel 31, and Jackson 26. Nattiel averaged 20.3 yards a catch, Jackson 16.8 and Johnson 16.3.

In the playoffs, Nattiel has six catches for an average of 17.6 yards; Jackson four for 33.5, including an 80-yard TD catch against Cleveland on which he caught a 12 yard pass, broke two tackles and went all the way, and Johnson four for 26.3, although he missed the Cleveland game with a groin injury.

"Those little guys make Elway really dangerous," said Ahmad Rashad, the former All-Pro receiver.

They also present a problem for Washington, which likes to use its top conerback, Darrell Green, man-to-man against the other team's top wide receiver.

The Redskins, meanwhile, will probably start 5-9, 173-pound Gary Clark and 5-11, 180-pound Ricky Sanders with Monk, who missed the last six games with a knee injury, in reserve. Both Clark and Sanders are refugees from the USFL, which also provided a boost to receivers of the minized persuasion, including Minnesota's Anthony Carter and Cleveland's 140-pound Gerald McNeil.



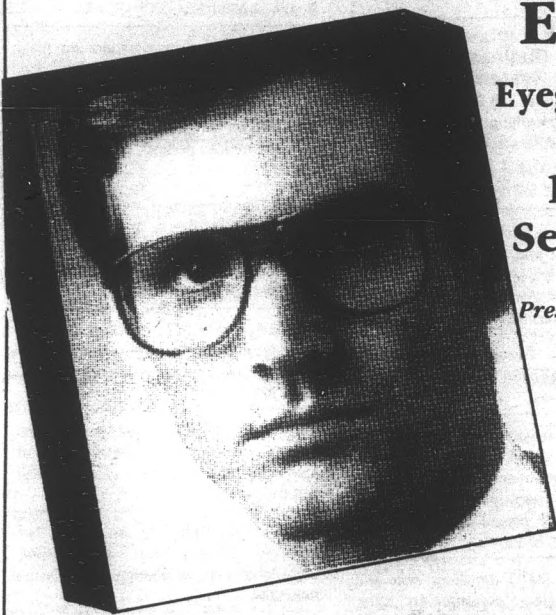

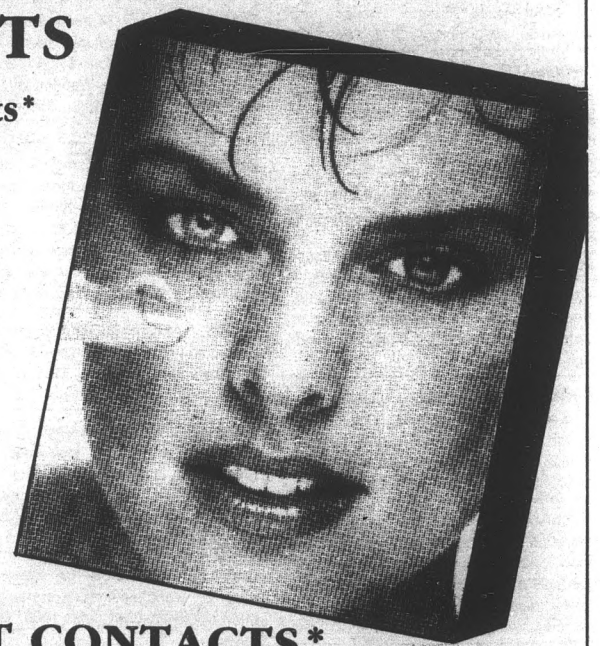
