

Million gallons of toxic waste near ASU East

Students at the new ASU East campus have an unwelcome neighbor — about a million gallons of toxic waste.

The site is contaminated with JP-4 and aviation gasoline that spilled or leaked from underground steel storage tanks over the 52 years Williams Air Force Base was used to train pilots, said Joe Martin, base installation manager. ASU received the land from the Air Force last year.

The waste is located in an aquifer — an underground lake — about 220 feet down, and covers 4.4 acres.

However, Air Force officials said it would not affect anyone living in the area.

"The aquifer is not a source of drinking water," said Dr. William Harris, environmental coordinator for the Air Force Base Conversion Agency.

The AFBCA is a Department of Defense agency in charge of returning decommissioned military bases to civilian control.

The waste won't affect ASU's move to the new campus either, said Charles Backus, ASU East director of Academic programs.

"It's not a problem at all," he said. "The site isn't in the ASU East footprint."

"All the risk is within acceptable risk levels, as established by the Environmental Protection Agency," Harris said. "People coming here to work, live or study should feel comfortable that there has been more oversight at this facility than any other (former military) facility."

Designated an Environmental Protection Agency Superfund site in 1987, the agency monitors the base cleanup with the Arizona Department of Environmental Quality.

New day planner packs heat, not notes

Instead of packing class notes in their daytimers, some students may soon be packing heat.

A newly introduced product called the "Anytimer" looks like a normal organizer, but is actually a concealed weapons case. The lightweight leather case holds most types of handguns, as well as an additional magazine.

Students shouldn't be tempted to bring it on campus, however, since firearms are prohibited at ASU, said ASU Chief of Police Lanny Standridge.

Although he said the Anytimer won't raise any suspicions, he is unsure if it will lead to an increase in guns on campus. Students who want to bring weapons on campus will do so with or without a fancy case, he said.

"It would seem to me that anyone that feels the need to carry a concealed weapon will find a way to do it," Standridge said.

Dan Tschudy, inventor of the Anytimer, said some college students have contacted him about the product, but he hopes none of them plan to use it illegally.

"It's their choice. It's not our responsibility that they follow the law," he said.

Tschudy, a retired police detective who now runs a private investigation agency in Scottsdale, said he wanted to design a way to carry a concealed weapon in a less conspicuous manner.

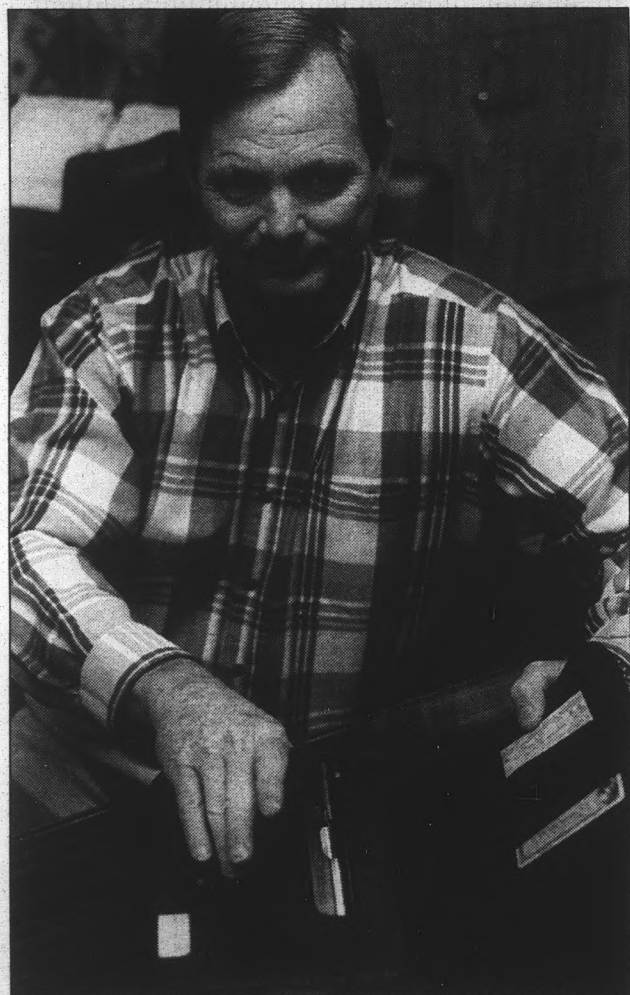
"It doesn't look out of place," he said. "It's very non-threatening."

The case has a leather exterior with a double zipper. Inside there is a sculpted foam molding which can be customized to fit different types of weapons. There is also a clear plastic flap inside to carry credit cards or other items.

Arizona law requires people to obtain a permit to carry a concealed weapon. The process involves 16 hours of training and a shooting test.

Project plots ASU's course into 21st century

University officials are trying to lay the foundation for ASU's future — today.

The University for the Next Century project, chaired by University President Lattie Coor, is a year-long study to match ASU's future goals with the needs of the 21st century. The study focuses on advancements in teaching, research and service up to the year 2010.

"We are hoping to set some strategic, long-term directions," said Provost Milton Glick. "If we know where we want to be 15 years from now, that should affect what we do now."

The project consists of three committees designed to focus the research as the study progresses.

"It is a step back to take a long-range view of what the University will look like (in the future), and how ASU will serve the Valley and the state of Arizona," Glick said.

The project has three parts: a committee focusing on ASU, a second looking to community needs and a third laying out national trends.

The ASU committee was established last fall to define the University's long-term mission and organization. The community committee is also working to design services for the Valley. The third committee will focus on how the University's goals fit into national education standards.

Members of the national committee are highly recognized in the world of academics, Glick said.

Administrators are also looking at the roles ASU's West and East campuses will play in the future.

"It will help ASU West define its particular niche within the broad visions of the University," said Ben Forsyth, ASU West provost.

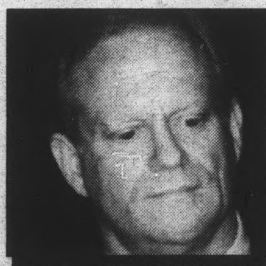

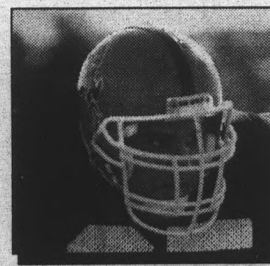

the Arizona Department of Water Quality and the U.S. Air Force Center for Environmental Excellence.

The estimated cost of the clean-up is \$25 million, and it could take as long as 50 years to remove the hazardous chemicals.

Estimates of the fuel spill's size vary from 650,000 gallons to 1.5 million gallons, Harris said, because "the base was so active (operationally) that it's tough to know how much actually spilled."

The AFBCA drilled seven extraction wells to remove the fuels, and has pumped out 25,000 gallons of the waste so far. But at a cost of \$2,000 a gallon, "the wells didn't do what we thought they would do," Harris said.

He said the AFBCA is currently looking at other methods, including aerobic degradation, which uses naturally occurring bacteria to help clean the site.

The JP-4 site is one of 166 original "areas of concern" on the former air base. Harris said 33 sites have been carried into further investigation, including the JP-4 site.

Other sites include a landfill, which has been capped, fire-fighting training areas,

and the site of a former paint shop.

Many of the residents that live near the waste site were unaware of the fuel spill.

"I didn't know about the leak," said Penny Smith, who lives less than a mile away from the spill in housing provided by ASU East. "I worry about seepage, that it might eventually go down into the water table, but I imagine they're are keeping an eye on it because they don't want to be sued."

Harris said the spill poses no danger.

"The actual quantity isn't as important as where it is and where it's going, and what the potential risk is."

More than 40 test wells have been drilled around the former air base to monitor the movement of the waste during the past five years. Since the AFBCA began monitoring the wells, Harris said there had been no "appreciable migration" off site.

Michael Breazeale, a field engineer for the Air Force Center for Environmental Excellence, said the waste is not a risk to humans because the majority of it is underground. He said that someone would have to inhale it, eat it or drink it to be harmed.

said he's not sure if the Anytimer will prompt more students to carry concealed weapons on campus.

"It's any man's guess," he said.

Students need to do something to protect themselves, Janeczek said, adding that guns should not be prohibited from campus in the first place.

However, Standridge said allowing weapons on campus would definitely lead to more problems.

"Everyone needs to comply with the law for everyone's safety," he said. "I regret that anyone would feel so threatened that they would have to carry a concealed weapon for their protection."

The Anytimer came out in June and about 150 have been sold nationwide. The basic model costs \$99 and an upcoming design that holds larger weapons will go for \$125. Anyone interested in the case should call 423-9346 for more information.

Symington files bankruptcy; owes \$24M

Governor's assets to be auctioned to pay creditors

PHOENIX (AP) — Gov. Fife Symington, a real estate developer who was elected on a promise to apply his business acumen to state government, filed for bankruptcy Wednesday, claiming \$24 million in debts from deals gone bad.

The filing came after creditors who foreclosed on a shopping center he developed refused his offer to settle an \$11.4 million debt for less than 10 cents on the dollar.

He listed debts of nearly \$25 million and assets of \$61,000.

"This is a very difficult thing to go through," Symington said. "For me to work 15 years to build up all those projects and to lose it all is tough. ... I think I'm just sad."

It was the latest in a string of financial setbacks for the 50-year-old Republican, who took office in 1991 and was re-elected last year, just six months after settling a lawsuit by savings and loan regulators over another of his ventures.

"I think the voters were willing to give him a pass in 1994," said state Sen. Chris Cumiskey, a Phoenix Democrat. "I don't think they'll be quite as charitable in 1998."

Two weeks ago, Symington offered to settle with the pension funds by turning over 25 percent of his \$75,000-a-year state paycheck. That prompted criticism that the man who promised to run Arizona like a business was acting

more like a deadbeat.

"To me it sounds like he can tell a deadbeat dad that they need to pay, but now he's a deadbeat governor," said Sen. Sandra Kennedy, D-Phoenix. "This is a credibility issue. When the governor turned his back on his responsibility to pay his bills he showed once and for all that he cannot be trusted to do the honorable thing."

Keith Overholt, an attorney representing the three unions that operate the pension funds — the Operating Engineers, Carpenters and Laborer Teamsters and Cement Masons — said the point is not whether the funds would be irreparably damaged.

"The people he failed to repay are the men and women in the construction industries who are his constituents," Overholt said. "That's quite a breach of faith."

Under the Chapter 7 proceeding, a trustee appointed by the U.S. Bankruptcy Court will sell off Symington's assets and distribute the proceeds to his creditors. The creditors, including the pension funds, will get less than one-third of a cent on the dollar, predicted his lawyer, William Novotny.

"They had a chance to get something," Symington said of the pension funds. "Now, because of the Chapter 7 filing, they'll get nothing because I have no assets."

The six union pension funds financed construction of the Mercado, a complex of offices, shops and restaurants in downtown Phoenix. The complex is only partly occupied and has never made money.

The unions foreclosed on the loan in 1991, and were

Earthquake shakes up California

No injuries reported

RIDGECREST, Calif. (AP) — A powerful earthquake centered beneath this Southern California desert town on Wednesday rocked an area from the Pacific Ocean to Nevada. There were no immediate reports of injury or damage.

"The earth bucked. That's what it felt like," said Scott Farwell, managing editor of the *Ridgecrest Daily Independent*. "It shook for a good long while, maybe as long as 30 to 40 seconds."

The magnitude-5.5 quake was centered 10 miles north of Ridgecrest, said Jay Alfer, a spokesman for California Institute of Technology in Pasadena. A magnitude-5.4 earthquake centered in the same area hit Aug. 17.

Wednesday's quake was felt in Los Angeles, Riverside, San Bernardino and Orange counties, and as far away as Las Vegas. Ridgecrest, population 28,000, is about 100 miles north of Los Angeles.

Floyd Hickey, who lives in Tehachapi, about 65 miles southwest of Ridgecrest, said he was laying on his sofa "and the couch just started moving and I thought the house was being exorcised or something."

He said the sofa "moved maybe four or five inches across the room and the coffee table was moving a little bit. It was like a strange phenomena," he said.

The quake also moved furniture at the Ridgecrest sheriff's station, Kern County sheriff's Deputy Steve Snead said. He said authorities did not immediately receive any reports of damage or injuries.

Farwell said he drove across town and didn't see any damage.

AT&T to split into 3 companies

NEW YORK (AP) — AT&T Corp. is splitting into three companies in a stunning move that could help it get back into local phone service, the business it was forced to give up in the 1984 breakup of Ma Bell.

The telecommunications giant is also junking its personal-computer manufacturing business, acknowledging that its 1991 merger with NCR Corp. was a disaster.

"AT&T is reinventing itself once again," chairman Robert Allen said Wednesday.

AT&T will break into companies that will focus on communications services, communications equipment manufacturing, and manufacturing of large computers. Shareholders will get a stake in each new company.

The move — which by some measures is bigger even than the 1984 breakup of AT&T — stunned Wall Street, which has seen one colossal merger after another in the telecommunications and entertainment industries.

Founded as Bell Telephone in 1877 by Alexander Graham Bell, AT&T has built itself into a giant whose stock is the most widely owned in the nation and is said to be a part of every widow's portfolio.

In 1984, facing a government antitrust suit, AT&T agreed to split into seven regional Baby Bell phone companies in a settlement that spawned the era of global telephone competition.

Under the settlement, AT&T is barred from buying a Baby Bell because that would reconstitute AT&T's monopoly over local and long-distance service.

However, once AT&T sets up a separate telephone equipment manufacturing compa-

ny, the communications-services company is more likely to pursue a partnership with a Baby Bell.

Such partnerships weren't realistic for AT&T after the 1984 breakup because local phone companies are the biggest customers of AT&T's equipment business. AT&T probably would have lost those customers by directly challenging them.

Legislation now in Congress would make it even more attractive for AT&T and other companies to enter the local phone business.

"This restructuring of AT&T is the next logical turn in our journey since divestiture," Allen said. "In recent months it's become clear to me that for AT&T's businesses to take advantage of the incredible growth opportunities in every part of the information industry it has to separate into smaller and more focused businesses."

The communications services business, which includes long distance, cellular service and credit-card calling, will retain the AT&T name. Names for the others have not been selected.

AT&T's computer operation will eliminate 8,500 of 43,000 jobs this fall in a move expected to cost \$1 billion. The company will quit making personal computers — an area where competitors operate more profitably — but continue to manufacture larger computer systems.

When it acquired NCR, AT&T had hoped to combine communications expertise with computer manufacturing.

But the NCR unit — later renamed AT&T Global Information Systems — has been hit hard by the shift in demand from

mainframe computers to networks of smaller machines. It lost \$332 million in the first two quarters of this year.

AT&T did not indicate any other cuts in its workforce of 303,000.

The breakup comes at a time when many other big telecommunications and media industry companies have been coming together in the belief that being big will mean more growth.

"In a time when scale is all the rage, to see AT&T walk in the other direction is a major wake-up call," said Mark Plakias, analyst at Strategic Telemedia in New York.

AT&T shares were up \$6.12 1/2 at \$63.75 on the New York Stock Exchange at the close of Wednesday's trading.

The Justice Department said it will review AT&T's plans but noted that corporate spinoffs do not typically raise antitrust concerns.

Executives at the regional Bell companies were quick to read AT&T's intentions.

"This is a clear signal that the surviving AT&T is preparing to focus on its entry into the local exchange business, which would be packaged with its long distance and wireless capabilities," said Ray Smith, chief executive of Bell Atlantic Corp.

Based on AT&T's 1994 revenue of \$75 billion, the three-way split is larger than the 1984 breakup. AT&T had revenue of \$58 billion in 1981, the year before the settlement of the government antitrust suit, and employed more than 1 million people.

But in terms of assets, AT&T today has about \$80 billion compared with \$138 billion in 1981, when it was the Bell system monopoly.

U.N. suspends airstrikes against Serbs

SARAJEVO, Bosnia-Herzegovina (AP) — NATO said Wednesday it would halt airstrikes against the Bosnian Serbs because the rebels have withdrawn their heaviest guns from around Sarajevo and eased the siege of the city.

A joint statement by NATO and the United Nations said commanders had agreed "that the resumption of airstrikes is currently not necessary." But they reserved the right to resume airstrikes in the event of Serb attacks on Sarajevo or other U.N.-declared "safe areas."

The Serbs allowed peacekeepers free movement in the 12 1/2-mile exclusion zone around the capital Wednesday to observe withdrawal of heavy weapons.

"(We are) happy that around 250 weapons of the designated caliber have been removed," said a U.N. spokesman, Lt. Col Chris Vernon. The withdrawal agreement does not affect artillery smaller than 100 mm, meaning the Serbs can still have a strong presence in the zone.

With Serbs permitting the United Nations "unimpeded movement" into Sarajevo by land and air, "we are content that compliance has been met" with NATO demands, Vernon said shortly before the 10 p.m. (1 p.m. Arizona time) deadline expired.

Drastic cuts in education jeopardize students' future

While you are choosing classes and making the decisions that will help you build a good life for yourself, the Congressional majority is working to make drastic cuts in education — in your student loans, in national service and even in your scholarships. These cuts will jeopardize the future you and your generation are working toward.

I oppose these cuts. I will do everything in my power to fight them and to see to it that the dream of higher education remains real for all Americans. I will do this not only by defending the opportunities of those of you who are already in college, but by opening the doors further to make sure that even greater numbers of deserving Americans have the chance to stand where you stand today.

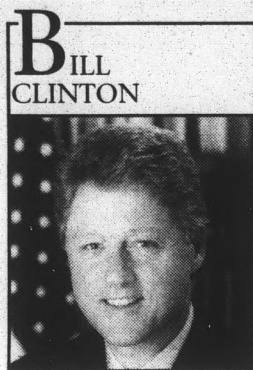
For the first time in a long time, leaders from both parties are resolved that we must balance the federal budget. From the day I took office, I've been committed to this goal — to getting rid of the budget deficit that quadrupled our national debt in the 12 years before I came to Washington. So far, we have made great progress.

In three years, we have cut the deficit nearly in half, from \$290 billion to \$160 billion. Now we are ready to eliminate the deficit entirely. On this, the Congressional majority and I see eye to eye.

But just how we get rid of the deficit is another matter. The majority in Congress wants to balance the budget in seven years, and do it while giving an unnecessarily large tax cut. But in order to do these things, the Congressional majority would make enormous cuts in education.

My balanced budget plan would take more years than Congress' to eliminate the deficit, but that's a small price to pay to keep your scholarships, your student loans and national service safe and well. It would also preserve our ability to protect the environment and the integrity of Medicare for our older citizens.

Balancing the budget is about more than numbers. It's about our values and our future. Education has always been the currency of the American Dream. When I was

your age, it was assumed — based on our long history — that each generation would have a better life than the preceding one. More than anything else, a good education is the way we pass this vision on to those who come after us.

The facts speak for themselves. Earnings for those with no post-secondary education have fallen substantially in the last 15 years. The only people for whom earnings have increased steadily are people exactly like you — those Americans with more education. Every year of higher education increases your earnings by 6 to 12 percent. Those years also mean a stronger overall economy and richer lives for those who have them.

Balancing the budget will be good for our economy and your future if it's done right. But simply balancing the budget won't do us much good in the long term if your generation does not have the education it needs to meet the challenges of the next century.

Just think about what the Congressional majority's plan, if it went through, would do to you, your classmates and any of the one out of two college students who receives federal aid.

It would:

- Raise the cost of student loans by \$10 billion over seven years by charging you interest on your loan while you are in school. This would increase the cost of a college education by as much as \$3,100 for undergraduates and \$9,400 for graduate students.

- Deny up to 360,000 low-income students desperately needed Pell Grants in 1996.

- Shut down Americorps, our national service initiative, which gives thousands of young people the chance to earn and save money for college while serving their country.

By contrast, my balanced budget plan builds on the national consensus that we must help people help themselves through the power of education. It eliminates both of our deficits: our budget deficit and our education deficit. My plan cuts wasteful spending by more than \$1 trillion, but it also increases investments in education by \$40 billion over the next seven years.

Think about how my balanced budget plan would help guarantee your future and all the hard work you're about to put into it.

It will:

- Increase funding for Pell Grants by \$3.4 billion. Almost one million more students would benefit from the scholarships. And we would raise the top award to \$3,128 by the year 2002.

- Expand Americorps to let even more young Americans serve their communities and go to college.

- Protect our direct-lending program, which makes student loans more affordable, with more repayment options, and saves taxpayers, parents and students billions of dollars.

I just returned from Pearl Harbor, where I took part in ceremonies marking the 50th anniversary of the end of World War II. In the 1940s, when the veterans we honored left their loved ones to go off and serve their country, they were the age most of you are now.

When they came home, the country recognized their service and their potential, and it responded with the G.I. Bill, which guaranteed a college education to every returning veteran. Those who served weren't given a handout, and they didn't want one. They were given the opportunity they needed to take responsibility for their lives.

Your generation has its own battles to wage. You face the choice of doing something right and difficult — or something easy and wrong.

In taking on the responsibility of educating yourselves, you have chosen the right and difficult path. You did the work you had to do to get into college. You may be working now to pay your way. And your family may have worked long hours and made great sacrifices to help you get where you are.

You deserve the nation's support. And your future success will likely repay our common investment. I do not accept the arguments of those who condemn irresponsibility in young Americans and then seek to deny the nation's helping hand to the millions of you who are doing the right things.

I hope you'll support my efforts to protect education and balance the budget. The fight for education is the fight for your future. In my life — and in the lives of countless Americans — education has meant the difference between the impossible and the possible. It should be true in your lives, too. With your help, we'll keep it that way.

A Mother's tragic brush with injustice not to be forgotten

This is a mother's story about her tragic brush with injustice.

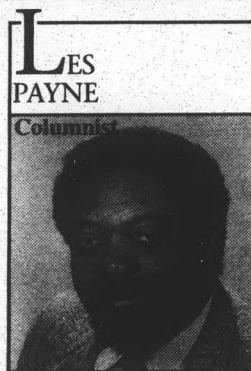
Mamie Till-Mobley lost her son 40 years ago this month, and will not let it die quietly. Her courage has helped shape the views of a generation of Southern black men about terror and racial injustice in the courtrooms of America. Skipping the big lessons, she just tells her story about the lynching of Emmett Till.

On the recent anniversary of the day her son died, she mounted the box that gave her the height to peer over the lectern of the Slave Theater in the heart of Bed-Stuy. She opened with a slide of her only son as a baby, then flashed one of him as an adolescent and, finally, she kept up the snapshot of her son laid out in an open casket with his unforgettable face.

Tears of anger welled up in strong men at the sight of the 1955 photograph from *Jet* magazine. It brought back one of the most galvanizing acts of domestic terror. Some 600,000 blacks reportedly filed passed Till's casket. Twenty percent of the viewers were overcome by the sight and had to be helped away.

The entire ordeal for Till-Mobley was "an adventure in terror."

"I took one look at Emmett's body and it seemed that every bone in me turned to steel," she said during a phone interview. "I knew that I had a job to do. I told those

around me to turn me loose, I'm not going to faint now, I have too much to do."

Young Emmett had gone to Money, Miss., from Chicago to spend the summer with his uncle Mose Wright. In a widely-circulated account doubted by his mother, Emmett was said to have wolf-whistled at the wife of a white store owner. For this crime against Southern white humanity, the woman's husband, Roy Bryant, and his brother-in-law, J.W. Milam, abducted the teenager from his uncle's house. An eyewitness saw the men take Emmett into a barn, where they beat him for about four hours, long after his screaming subsided.

"When I saw the body, it looked like a savage beast had worked my son over, not human beings. His tongue was choked out of his mouth. You could see just two or three teeth, which I could recognize because I thought he had the most beautiful teeth in the world. I looked at his nose and it looked like chopped beef. I found one eye on his cheek, the other one was gone. But I could identify the eye.

I looked further around his head. He only had two half-ears because the back part of his head was completely gone. There was a bullet hole through the temple area through which I could see daylight on the other side.

I wanted people to see exactly what I had seen.

There was in Mississippi what passed for a trial. Milam and Bryant had confessed to the kidnapping and later would sell the details of their sordid murder of Emmett Till to writer William Bradford Huie for \$4,000. The duo told Huie they were surprised that Emmett was not afraid of them. When he told them that he had a white girlfriend back in Chicago, Bryant said, it sealed his fate. After the

bludgeoning, they shot him over the right eye, weighted his body with the fan of a cotton gin and dumped him into the Tallahatchie.

"The temperature in the courtroom was 118 degrees," Till-Mobley said. "I didn't feel the heat, but I felt the heat of the hate that was being generated in that courtroom against me. I was causing trouble in Mississippi." The defense claimed that she had conspired with the NAACP to fake the murder.

In the most dramatic and courageous moment in the trial, Mose Wright, when asked to identify the abductor, pointed at Roy Bryant and said, "Dar he." Despite the evidence, the all-white jury took one hour and seven minutes to rule the two white men not guilty.

Certain of the outcome, Till's mother had left the trial early and headed home to bring her case to the court of public opinion. "I thought we were the kind of black people this would never happen to. We were God-fearing. I brought Emmett up in church. We were all active church members. My son was blameless; he died a sacrificial death so that men would be able to live in (racial) peace here on earth."

awarded an \$11.4 million by a judge earlier this summer. Symington also owes some \$14 million to banks and other lenders, all resulting from the collapse of his real estate empire.

The filing won't hurt union retirees because the loss amounts to less than two percent of the funds' total assets of \$500 million, said Paul Morton, vice president of McMorgan & Co., the San Francisco-based investment manager for the pension funds.

The \$61,000 in assets Symington listed in the bankruptcy filing included such things as \$1,500 worth of clothing, a \$100 watch and Arizona State University football season tickets.

Not listed were family trusts created by Symington's grandfather, from which he

earned \$38,000 last year, and the holdings of his wife, Ann, including the family home.

Symington said neither the family trusts nor his wife's holdings are involved in the bankruptcy.

Last year, Symington and other former directors of the failed Southwest Savings and Loan Association agreed to a \$12 million settlement of a \$200 million lawsuit filed by government regulators after the thrift's collapse.

The federal Resolution Trust Corp. accused Symington of improperly using his position as a Southwest director to persuade the thrift to invest in one of his projects.

Symington was not required to pay any of the settlement or admit any wrongdoing.

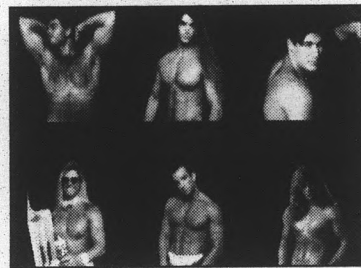

Charles Calleros, chairman of the Campus Environment Team, defended the right of the mall preachers to be on campus.

"Speech about issues like that is what makes a campus, whether it is controversial or provocative," he said. "It is characteristic of a college campus and part of the learning environment."

Calleros said the preachers are protected by the First Amendment of the Constitution even though some people find them "fairly offensive." However, they may not cause any disruptions, physically harass students or "back anyone into a corner."

"This is a public campus," Calleros said.

"If people don't want to listen, they can pass by."

Not all students mocked the "brothers." "The listeners here are getting the opportunity to act immature," senior accounting major Jess Rankin said.

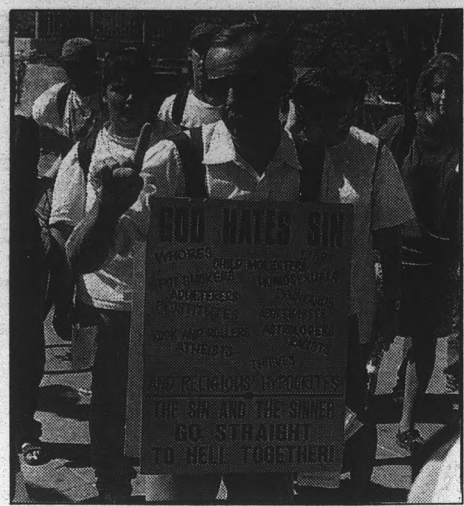
Ladomato remained committed to preaching his beliefs to the jeering crowd.

"People want to continue in their wildness," Ladomato said. "They have turned away from God's truth."

"Students act the same wherever I go ... man has the same evil heart," he said.

"Leave him alone," Kiene said. "People are just encouraging him and we don't want them here."

"They are not helping anyone, they are just insulting us," he said. "His telling me that I'm going to hell is not going to help me."

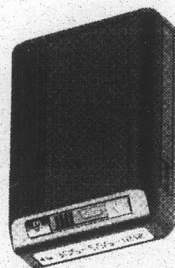

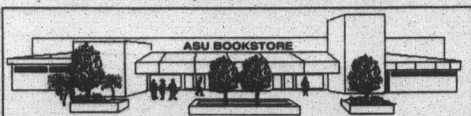
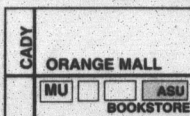

Senate halts plan to 'tax' universities

WASHINGTON (AP) — A key Senate Republican's plan to cut federal spending on student aid crumbled Wednesday after fellow Republicans balked at a proposed new fee on colleges.

"What we're faced with is a lot of bad choices," said Sen. Mike DeWine, R-Ohio. "We're trying to see if there's any other options we might look at."

Democrats also oppose the plan by Sen. Nancy Kassebaum, R-Kan., calling it a new tax on middle-class families struggling to put their kids through college.

Kassebaum, who chairs the Senate Labor and Human Resources Committee, said she does not like the idea of cutting \$10 billion from student aid. But she must under the budget plan negotiated by House and Senate Republicans, Kassebaum noted.

The plan she announced Tuesday would make

the \$10 billion in cuts by charging universities a 2 percent fee on the volume of their student loans.

It also would reduce by two months the current six-month, no-payback grace period for students. And it would make student loans less lucrative for banks and guaranty agencies, and more costly for some parents.

But it was the fee on colleges that forced Kassebaum to postpone a planned Wednesday vote on the proposal.

"That, frankly, gives me a lot of concern," DeWine said. "This is a new fee they're not used to paying, and it would have a big impact."

Universities would pass the fee on to students, said Edward Kealy, director of the Committee for Education Funding, which lobbies Congress on behalf of colleges.

"It's a tax, and they would have to find some way to pay it," Kealy said.

Other Republicans, led by Sen. Dan Coats, R-Ind., believe the Senate should cut student aid, instead, by halting President Clinton's program of offering schools a direct-lending alternative to the current guaranteed loan system.

Under the current system, banks make loans to students and the government guarantees them. Under direct lending, the federal government loans money straight to students.

Republicans have generally been leery of direct lending. But Kassebaum said she would hesitate to end it entirely because it has created healthy competition with banks.

Any abrupt change in the program also could cause chaos for the 1,400 colleges already enrolled in direct lending, DeWine said.

"We want to come up with what's the least disruptive to higher education," said DeWine. "Clearly, the committee is not settled on anything yet."

Center Robertson rebounds from knee injury

After being moved to the center position late last season, Kirk Robertson had found his niche.

He started in three of the last four regular season games and was ready to take the helm when the 1995-96 season began. Then he took a bad hit on the last day of training camp and the season almost passed before his eyes.

"I got hit by someone up in Tontozona and I sprained my medial collateral ligament," Robertson said.

However, Robertson was cleared to play Monday and has a chance to see action this weekend when ASU meets Oregon State at Sun Devil Stadium, ASU Head Coach Bruce Snyder said.

Snyder added he is anxious for Robertson to return so the offensive line will have more flexibility.

Robertson has battled knee problems throughout his career, including a rough 93-94 season spent playing while rehabilitating from surgery on both knees.

The surgery was performed to correct a genetic problem causing frequent dislocation of the knee. After fully recovering, the idea of potentially missing an entire season this year left Robertson concerned.

"The first week or so I was worried because I didn't know if I would be able to play this season," Robertson said. "Without a definite on what was wrong it was a very tough time emotionally. I kind of secluded myself from the team."

After talking extensively to his family and various doctors and leaving adequate time to heal, Robertson was given clearance to begin rehabilitation.

For more than a month, Robertson has been working out and preparing himself to

get back into the game.

"It's kind of dramatic when something like that happens," Robertson said. "I put in four to five weeks of hard work and I feel like I'm getting in shape."

Hard physical work wasn't the only kind of rehab Robertson worked at. He also put a lot of visualization techniques to use.

"In rehab I tried to put everything I was doing in the perspective of being in a football game," he said. "I did a lot of mental reps to get myself back into shape."

"The more reps I do the stronger I get."

He currently estimates his knee at 90 percent capacity.

Robertson, who returned to practice Tuesday, said he isn't too worried about getting back into the swing of things.

"It was a little hard to get back into it and I was nervous, but I was also very anxious to get back to hitting again," Robertson said. "Once I get used to being back in practice, I just want to help the team."

"We need to start winning."

The possibility of reinjuring one or both knees is still in the back of his mind, Robertson said, but he added that he won't think about it when he is out playing.

"This could have stopped my whole season and it could have been a lot worse," he said. "It could happen again, but if you think about it, it's going to happen."

Even so, Robertson said he will be exclusively concerned with taking down the opponent on game day.

"I just have to go out there and worry about hitting him (the opponent)," he said. "I can't worry about my knees."

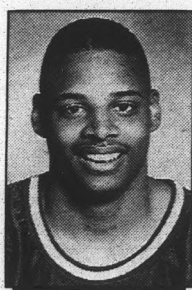
"The possibility of me hurting it again is slim because they've got me taped up pretty tight."

Decision postponed on charges for Bennett, Capers

The decision on whether to file criminal misdemeanor charges against former ASU basketball players Mario Bennett and Marcell Capers for allegedly giving false information to a police officer has been delayed, said officials at the Maricopa County Attorney's Office Wednesday.

Bill Fitzgerald, who is heading the investigation for the Maricopa County Attorney's Office, said it will be at least three weeks until a final decision is made. Officials origi-

nally anticipated a decision last Wednesday, but Fitzgerald said the Department of Public Safety report was sent back to the DPS for further information.

"The case was not (formally) submitted," he said. "There are things we asked them to follow up on. There are questions we want answered. Witnesses need to be talked to and interviews need to be done."

Neither Bennett nor Capers could be reached for comment.

The investigation stems from a late-night car accident the two were involved in on the Squaw Peak Parkway at the McDowell Road exit Sept. 2. Investigators are evaluating evidence which suggested Capers and Bennett were not truthful about who was driving Bennett's 1995 Mercedes Benz at the time of accident. Capers told the officer at the scene he was driving the vehicle, thereby submitting himself to a field sobriety test which he passed.

Devils receive assistance from Angel

Freshman Darren Angel has arrived.

Angel had made his presence felt immediately last weekend by winning the Golfweek/Ping Preview in Cornelius, Ore.

With a three-round score of 209, Angel became the first freshman to win a tournament for ASU since Phil Mickelson in 1988-89 season.

"I didn't really think about winning the individual title," Angel said. "I wanted the team to win more than that. I was just trying to keep up my end of the bargain."

Coach Randy Lein said the course was challenging and the field of teams gathered at the tournament was impressive.

"It's one of the strongest fields we'll see until nationals," Lein said.

Angel said the degree of difficulty for the course was high.

"The fairways were pretty tight and the greens were tough to read," he said. "If you misread a green, it was tough to get the ball up and down from anywhere."

Lein said he wasn't surprised Angel performed so well

in the tournament.

"In my mind, he was one of the top two or three recruits in the country," he said. "For him to play as well as he did, I'm pleasantly pleased."

Added Angel: "I was three shots back after the first day and I thought the scores were going to keep going down, but nobody ripped it up."

Angel contributed his fair share of damage, shooting rounds of 71, 68 and 70 during the tournament.

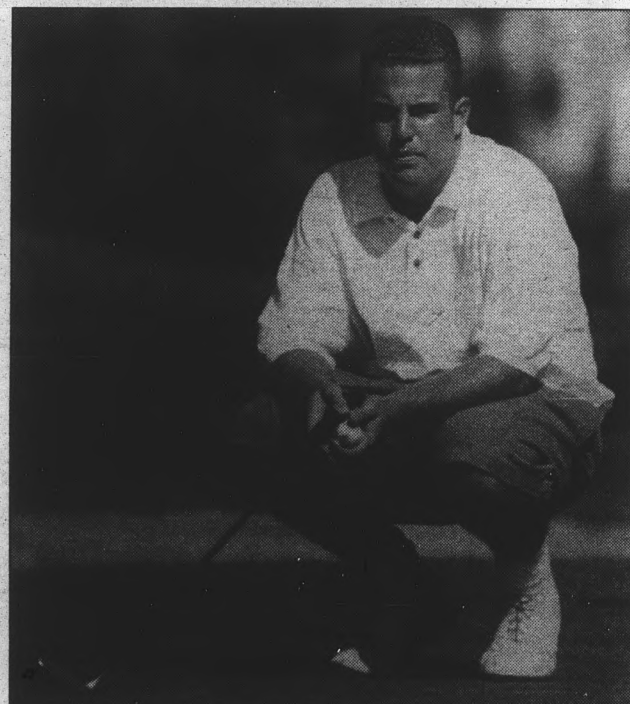
"I just wanted all my rounds to count," Angel said. "I didn't want to be the fifth man."

Despite the congratulations, Angel said he hasn't really felt the impact of the individual title honors. "I didn't even know (I had won) until the last round was over," he said. "It still hasn't really sunk in yet."

As for the rest of the season, Lein said now that Angel has won he knows he can play to win, not just to contribute.

"He'll be playing with a lot more confidence than he was a week ago," he said.

Lein said Angel can only get better and thinks he has a chance of setting some new records at school during his career in the program.

However, after eyewitness accounts and further investigation, DPS determined Bennett was driving the vehicle and the two had switched places. According to the report, Bennett smelled of intoxicating alcohol.

Officials said there is no evidence supporting DWI or

DUI charges against Bennett.

Bennett may be also be subjected to further charges because he was driving with a suspended driver's license.

Bennett declared himself eligible for the NBA draft last spring with still one year college eligibility remaining. He

helped lead the ASU basketball team to a Sweet 16 berth in the NCAA tournament.

The Phoenix Suns, who drafted Bennett with the 27th pick of the first round of the 1995 NBA Draft, could not be reached for comment.
