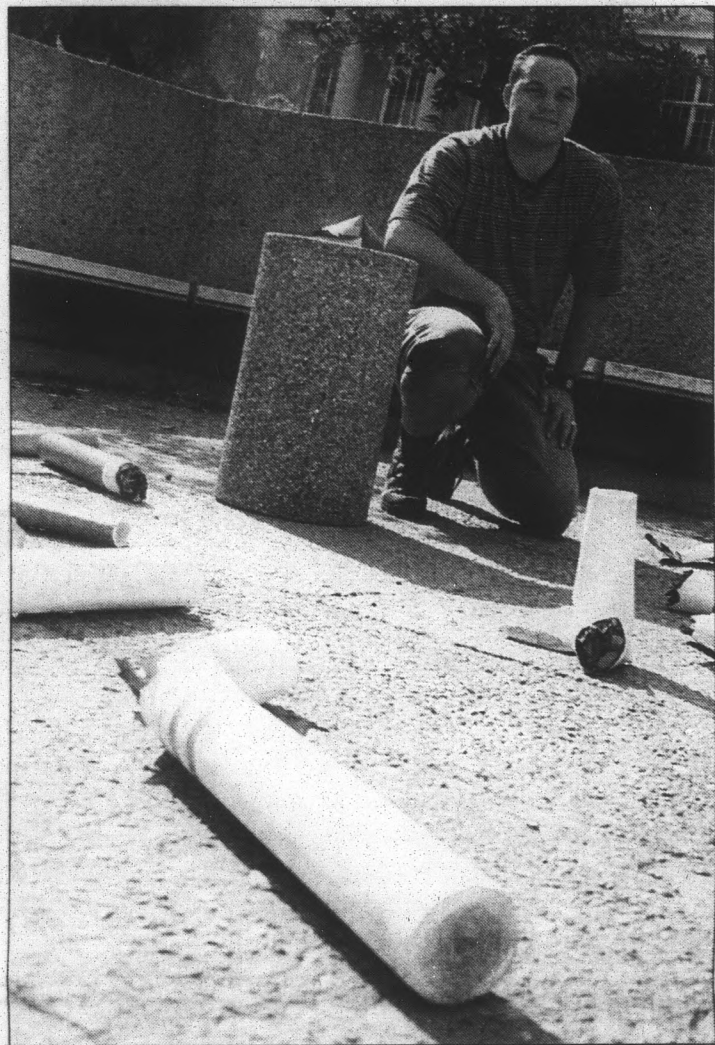

ASU student, 2 others shot after argument

An ASU student and two other men received serious injuries after being shot during an argument at a Mesa apartment complex early Wednesday morning.

Jason Payne, a freshman liberal arts major, was taken to Scottsdale Memorial Hospital for treatment. Matt Thorton, 21, and Eric Mauer, 20, were taken to Scottsdale Memorial Hospital and the Maricopa Medical Center, respectively. Neither hospital would release the victims' conditions, but police said that none of their injuries were life-threatening.

According to Mesa police, the three men got into an argument with a group of people at 2:15 a.m. in the outside commons area of Laguna Point

Apartments, 150 S. Roosevelt Road. The three went up to apartment 210 and, a short time later, one of the men from the other group showed up at the front door and began to argue with them again.

Someone fired several shots through the apartment's front door, hitting Payne, Mauer and Thorton.

Police have not made any arrests in the shooting, but have narrowed the suspects to two men. A search of one of their apartments turned up some weapons, but police will not know for a few days if one of them was used in the shooting.

Apparently, "tempers flared" and the shooting took place soon after, said Sgt. Tom Shields of the Mesa Police Department. Alcohol was involved in the incident, he added.

"It appears everyone was drinking," he said.

Police seek witnesses of brawl which took victim's left eye

Tempe police are still looking for witnesses to an alleged assault that occurred Oct. 22 at a bar and resulted in the loss of the victim's eye.

ASU student Chad Briggs, a senior accounting major, received a blow to the left side of his face with a beer mug during an altercation at Club 411, 411 S. Mill Ave.

The impact destroyed Briggs' iris and half of his retina. He will have his left eye replaced with a

prosthetic on Friday.

Briggs said he attempted to avoid an altercation with the two men.

"I was walking toward the front of the bar," he said, "and I bumped into this guy."

"He said, 'Don't touch me.' I said, 'It's cool.'"

As Briggs turned away from the men, he said he was punched in the face and then hit on the left side of his face with the mug.

"It kind of startled me," he said.

According to police, alcohol was a factor in the assault.

Det. Al Reed said police know who the alleged

Sheriff Arpaio addresses University audience, defends policies

Sheriff Joe Arpaio downplayed concern over federal investigations of his jails and defended his programs before a group of about 50 people in the Memorial Union Ventana room Wednesday.

"To all those critics," Arpaio said in his speech, sponsored by the Justice Studies Student Association, "hey, you're crazy."

Arpaio said the Justice Department had almost completed its investigation into allegations of mistreatment of prisoners, and he did not believe they would find any wrongdoing.

"There have been a couple of instances, but I'm not worried," Arpaio said. "I will take strict action against employees when they do something wrong."

"I prefer not to call it an investigation. I call it an inquiry," he added.

Arpaio claimed his jail system, the fourth-largest county jail system in the country, was the most efficient in the nation, with a meal cost of 30 cents per inmate. He said the programs commonly attacked by his

detractors — bologna-sandwich lunches, denying inmates coffee or "nude magazines," and building "tent cities" — were ways to save taxpayers money.

Arpaio said another of his plans to raise money, the now-infamous pink underwear, was inspired when he discovered inmates had stolen \$40,000 worth of underwear in eight months. He said he chose pink because it was a non-violent color and an unpopular choice for underwear.

"Pink is a nice color," he said. "But the reason I did pink (is because) they (inmates) hate that color."

A pair of official pink underwear costs \$10 to the public, and proceeds go to the sheriff's posse.

Arpaio said banning movies, denying prisoners cigarettes and housing them in tents — some of which are from World War I and have holes in the roof — is not inhumane, but he hoped it would serve as a punitive measure.

"They (the tents) do have holes in

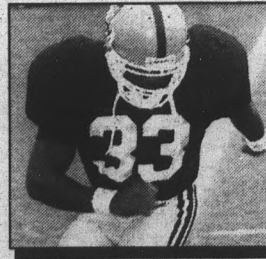

assailants are, but are still looking for witnesses, adding that the County Attorney's Office will not prosecute because of a lack of evidence.

"I'm going to do everything in my power to see that justice is served," Reed said.

According to Briggs, the assailants are students at South Mountain Community College.

"They (the assailants) admit to hitting me," he said, "but they say that they tackled me and I fell on the mug."

"(But) I was attacked."

Following the blows, Briggs said he was "semi-conscious."

"I remember only bits and pieces," he said.

Tempe police currently don't know of any witnesses to the assault, but Reed said they are continuing to investigate the attack.

"The place was packed. I can't imagine that no one saw it," Briggs said.

However, he said he has not allowed the incident to daunt him.

"I'm kind of pissed that I'm losing my eye," he said. "Life will be different. I don't think that I'll go out anymore. I don't know what I'll do."

"You have to cry, but you have to have a positive attitude. This is just another curve in life. What can I do, sit and pout? I'm not going to sit here and pout."

them," he said. "But it never rains here."

Another way Arpaio said he saves money — using the posse — has also come under fire.

"For all those critics out there waiting for the posse to shoot someone or waiting for the tents to collapse — it's been three years and they're still there."

Arpaio also stood by his use of chain gangs.

"They're volunteers," Arpaio said.

"When they smuggle something in, they spend 23 hours in a cell block. They volunteer just to get out."

Arpaio said even though his posse may have forced prostitutes off Van Buren Street, only to relocate on Apache Drive, he would not be sending the posse to Tempe.


"Maybe we did (force them to move to Tempe)," he said. "I want to force them out of the county."

He added that with the holiday season at hand, the posse's focus will be on patrolling Valley malls.

"I have to forget the prostitutes for right now."

Symington owes \$1M to lawyers, accountants

PHOENIX (AP) — Gov. Fife Symington owes more than \$1 million to his lawyers and accountants, according to a bankruptcy petition.

The amended document, made public Tuesday, shows \$666,397.46 of the governor's outstanding professional fees is owed to John Dowd of Washington, D.C., who has defended the governor in civil, criminal and congressional probes.

Symington owes \$230,000 to Snell & Wilmer, a Phoenix-area law firm that has handled the governor's personal and business work since the early 1970s. Outstanding accounts to three other law firms total \$138,000 and Symington owes two accounting firms a total of \$9,900.

During his first hearing before his creditors Tuesday, Symington testified that his legal and accounting fees continue to mount even though he has already paid hundreds of thousands of dollars.

The governor, a former real-estate developer, filed for Chapter 7 bankruptcy Sept. 20 after a consortium of union pension funds tried to collect on a \$10 million loan that Symington had personally guaranteed.

Former Cards player out of jail after disturbance

PHOENIX (AP) — Former Arizona Cardinals offensive lineman Luis Sharpe was released from jail Wednesday, a day after a woman accused him of kidnapping and sexually assaulting her at a hotel near here.

Sharpe, 35, is accused of disorderly conduct, sexual assault, unlawful imprisonment, aggravated assault and resisting arrest in the Halloween night incident at the Best Western Grace Inn in Ahwatukee, a Phoenix suburb.

Sgt. Tim Campbell, a spokesman for the Maricopa County Sheriff's Office, said a woman called about 11:30 p.m. Tuesday and accused Sharpe of forcing her to perform oral sex and slapping her when she refused to continue.

Computer glitch stalls lottery conversion, sales

PHOENIX (AP) — The Arizona Lottery's planned "big bang" conversion to a new system turned into a big fizzle Wednesday as a computer glitch shut down sales of Lotto and Powerball tickets all day before evening drawings for both games.

The changeover to the new system operated by Automated Wagering Inc. of Atlanta was to have taken place no later than noon Wednesday, lottery officials said last week.

But, as of late Wednesday afternoon, the conversion had not been completed and a spokeswoman for the lottery said it wouldn't be before midnight.

That did not sit well with would-be players who were not able to buy tickets for Wednesday evening's \$4.5 million Lotto drawing or the \$14 million Powerball drawing.

"You probably couldn't print my reaction in the newspaper," Tom Nowell, of Tempe, said after attempting to buy lottery tickets at a Circle K convenience store near downtown Phoenix. "I'm just very distraught. It's ridiculous."

Bosnia starts 'long journey' to peace

Christopher stresses importance of ending war now

DAYTON, Ohio (AP) — Opening peace talks with stiff handshakes, three Balkan presidents set out Wednesday on a "long journey" in pursuit of peace in Bosnia. If they fail, Secretary of State Warren Christopher said, Europe could be plunged into a wider war requiring American military intervention.

Sitting across a conference table from the leaders of Serbia, Croatia and Bosnia, Christopher said "future generations would surely hold us accountable for the consequences."

The aim is a settlement to end a 42-month war that has left tens of thousands of people homeless and sparked atrocities

unmatched in Europe since Nazi Germany killed 6 million Jews in World War II.

In a somber speech, echoed by European mediator Carl Bildt and Russian Deputy Foreign Minister Igor Ivanov, Christopher said Bosnia-Herzegovina was entitled to be "a country at peace and not a killing field."

"This will be a long journey," he said, "but it all starts here. Let's all get down to work."

The three Balkan presidents, Slobodan Milosevic of Serbia, Franjo Tudjman of Croatia and Alija Izetbegovic of Bosnia, made no opening statements. They shook hands at Christopher's urging, but did not smile at each other.

"The world can and will help you make peace," Christopher told them. "But only you can ensure that this process will succeed."

Shrugging off those who claim the ethnic rivalries are so long-standing and intense peace was unlikely, Christopher pointed to the Arab-Israeli conflict and the ones in Northern Ireland and South Africa as proof "negotiations can work when people are determined to make them work."

The talks, being held at Wright-Patterson Air Force Base near Dayton, then went into closed session. There is no scheduled windup date, and American mediator Richard Holbrooke, who will be in day-to-day charge, has said he would keep at it until there is some success.

Survey: 1 in 3 blacks believe AIDS was made to kill them

SAN DIEGO (AP) — A survey of about 1,000 black church members in five cities found that more than one-third of them believe the AIDS virus was produced in a germ warfare laboratory as a form of genocide against blacks.

Another third said they were "unsure" whether AIDS was created to kill blacks. That left only one-third who disputed the theory.

The findings held firm even among educated individuals, said one of the survey's authors, Sandra Crouse Quinn, a health educator at the School of Public Health at the University of North Carolina in Chapel Hill.

Rumors that AIDS was created to kill blacks have circulated in the black community for years, and the belief is endorsed by some black leaders.

The surveyed group was not necessarily a representative sample of America's black population, and the findings cannot be applied to blacks as a whole. But the researchers were surprised by the prevalence of such beliefs.

"They don't trust our public health data," said Quinn, who is white.

The belief that AIDS is a form of genocide has serious health consequences, Quinn said: "If they believe AIDS is a form of genocide they are less likely to get tested, less likely to use condoms and less likely to participate in clinical trials."

Although she has not surveyed whites on the genocide question, Quinn said, "I think most whites would say this sounds bizarre."

The wide disparity in world view between blacks and whites recalls the racial

chasm in the reaction to the O.J. Simpson verdict, she said.

Charles Hamilton, a political scientist at Columbia University, agreed.

"You have to put those attitudes in the context of general disaffection about the effectiveness of the system to deal with problems," said Hamilton, who is black.

"We still see this in response to why drugs are so prevalent in the black community: It's a conspiracy. If it weren't that, police departments would crack down on it."

The Rev. Joseph Lowery, president of the Southern Christian Leadership Conference, cited the Tuskegee experiment as grounds for cynicism about government health programs. From 1932 to 1972, the U.S. government withheld treatment from 399 poor black men with syphilis in order to study the consequences.

"It's been documented that the government did use African-Americans as guinea pigs in this experiment," Lowery said.

However, Quinn's study is based on survey questions that were asked in 1990, and Lowery said he believes AIDS education among blacks since then has probably reduced the percentage of those who believe AIDS is a government conspiracy.

"It might have been true in the 1980s, but there's been too much education about AIDS now for African Americans to believe that," he said. "They know about dirty needles. They know about unprotected sex."

In 1992, Dr. Abdul Alim Muhammad, the chief doctor of Louis Farrakhan's Nation of

House bans late-term abortions

WASHINGTON (AP) — Abortion opponents claimed victory Wednesday as the House passed a bill to ban a specific kind of late-term abortion.

"This is the key pro-life vote of the 104th Congress," Rep. Bob Dornan, R-Calif., said following the 288-139 vote to make it a felony for doctors to perform "partial-birth" abortions.

Abortion rights supporters were equally concerned that a ban on the procedure, thought to occur only several hundred times a year, would have larger ramifications.

The bill faces a tougher road in the Senate, although Democratic leader Sen. Tom Daschle of South Dakota said he suspects there is "a significant degree of support" there for the legislation.

The procedure, as described by supporters of the ban, involves the doctor pulling the baby by the legs through the birth canal until only the head remains inside the womb, then sticking a scissors in the skull and sucking out the brains so the head can pass out of the body.

Opponents argued that the procedure is used only in second- and third-trimester pregnancies where the life of the mother is in danger or severe fetal abnormalities are found. They also said the fetus usually dies from anesthesia administered to the mother before the procedure begins.

Yesterday, we said that Gov. Fife Symington should have dressed up as a bottle of Welch's grape juice for Halloween — so everyone could see what a welcher he is.

We take that back. He should have been Ronald Reagan.

At least, he should have been the Reagan of the Iran-Contra hearings — the one that kept saying that he couldn't remember anything about meetings involving shipments of weaponry to the Nicaraguan rebels.

Symington has obviously been taking lessons.

On Tuesday, Symington faced his creditors in bankruptcy court — and suddenly came down with the most convenient case of amnesia we've ever seen.

It was pretty much a broken record. We can just imagine what would have happened if we'd been one of the lawyers questioning him:

Who was authorized to write checks on your account, Gov. Symington? Can you give us names? After all, we'd assume that people know who has carte blanche to their banking accounts.

"I really don't remember."

You had to pay your creditors a certain amount of money to keep them from garnishing your governor's salary, Gov. Symington. How much did you pay them?

"I would have no way to answer that question today."

Gov. Symington, you quoted your net worth at nearly \$12 million in December 1989. Less than two years later, you were more than \$23 million in debt — a drop of more than \$35 million!

Then, seven months later, you reported that you were still in debt — but that you had managed to make up \$19 million of your previous debts. Then, in 1995, you were back down to \$24 million in the red.

It's hard to believe that a local real estate developer's net worth could fluctuate by tens of millions of dollars over the span of a few months. Are you being honest?

"I believe I'll have to go back and check the files."

You know, governor, this is interesting. This first statement, reporting your net worth at \$12 million, was filed with Valley National Bank in December 1989.

The second statement, filed with a law firm in May 1991, reported that you were more than \$23 million in the hole.

Then, in December 1991, you told another bank — First Interstate — that you were only \$4 million in debt.

Now, we're assuming that you we're filing these statements with the banks in order to get loans for your projects. We're further assuming that the statement filed with the law firm would help them determine how much to charge you in legal fees.

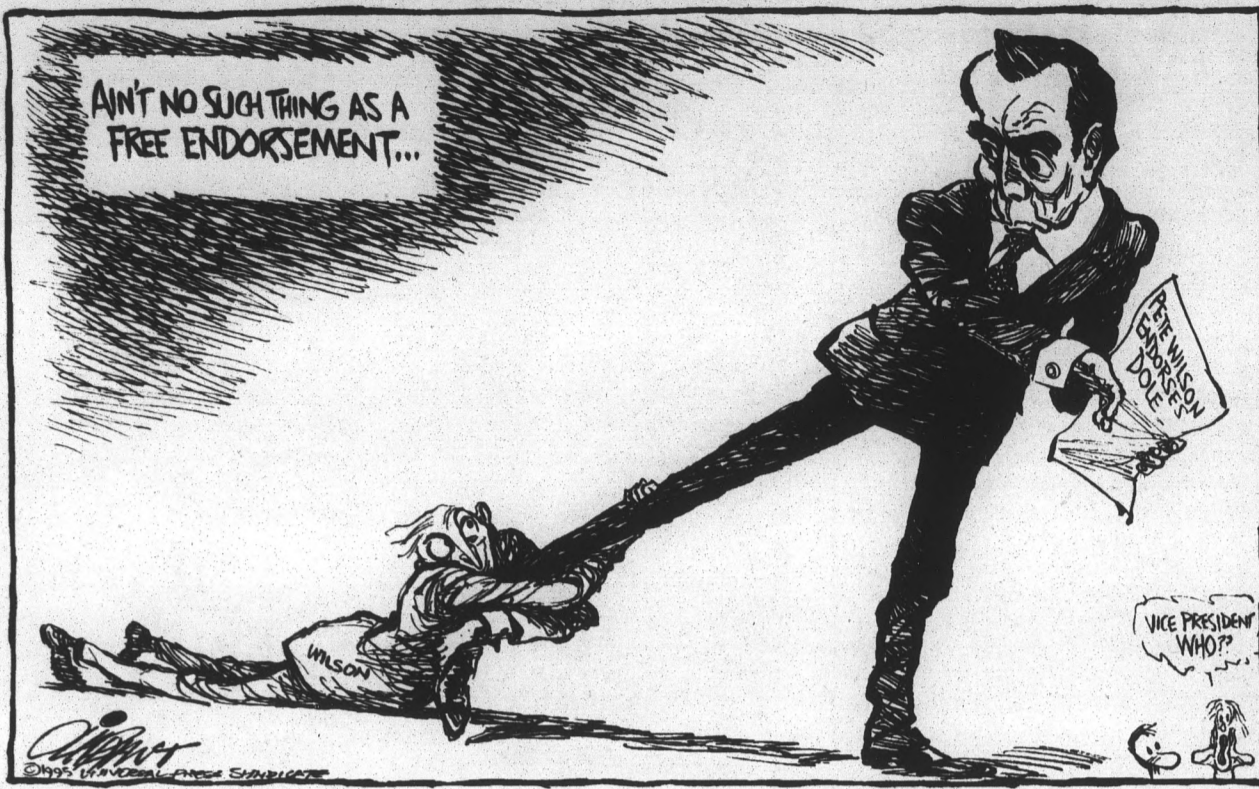
You seem to be giving fairly favorable accountings of your net worth when you're trying to get money, Gov. Symington. But, amazingly enough, you seem to be horrendously in debt whenever you have to pay people money, such as law firms or union pension funds.

Misrepresentation of financial well-being isn't very nice, Gov. Symington — and it's certainly not legal. Did you misrepresent your net worth on these documents?

"You should refer that question to my lawyers."

You seem to have great difficulty keeping your own records in order, Gov. Symington. Given this, how can you claim to be competent enough to hold the position of chief executive of a state of more than 4 million people?

"I don't know."



Weekend in Vegas spawns gambling monster

Entering the gambling world and leaving my Vegas virginity behind, I met the real city that never sleeps with naive eyes. Giuliani's snub of Arafat shows no control

By throwing Yasser Arafat out of a concert to which he held tickets, Mayor Rudolph Giuliani may have not only breached U.S. diplomatic protocol but also abused his authority.

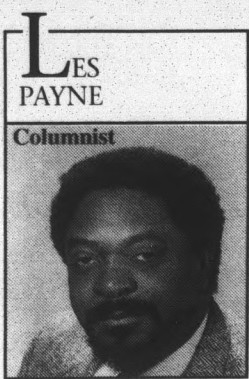
The White House and the State Department have condemned the mayor for his "unfortunate" bad manners during the 50th anniversary of the U.N. And it's no wonder: Palestine Liberation Organization Chairman Arafat had produced an invitation, from the U.N. chief of protocol, to the New York Philharmonic concert, which itself was underwritten by a corporate sponsor and hosted by the mayor and the City Host Committee.

Yet, despite these facts, in the middle of Beethoven's Ninth Symphony, Giuliani had his chief of staff swagger over to Arafat and ask him to leave the hall.

During its half century of New York terrain, the U.N. has entertained heads of State and others who were far more accomplished at quenching their bloodthirstiness than Arafat.

The chairman's misfortune is that, despite his conversion to peacenik, bashing him still reaps Giuliani some affection, support and a few notes from the city's Orthodox Jewish leaders.

"I would not invite Yasser Arafat to anything, anywhere, anytime," Giuliani said. "I don't forget." This parochial sentiment runs counter to the very spirit that nourishes the U.N., witness to many a guerrilla ascending to head of state. Arafat, Fidel Castro and Nelson

Mandela are but three examples.

The Arafat incident, the mayor's denial notwithstanding, was, in effect, a setup. The invitation and the concert tickets granted Arafat an official U.N. privilege and courtesy that Giuliani unilaterally yanked away.

Thus, the Nobel Peace Prize winner joins a growing line of officials, including the police commissioner and the former schools' chancellor, whom the mayor has suckered into an embarrassing position.

In a weird sidelight to the international brouhaha, the former mayor, who once called the United Nations a "cesspool," emerged to defend its honor. "(Giuliani) misuses this office and embarrasses the city when he engages in behavior that can only be described as rude," said Edward Koch.

Indeed, Koch, no friend of the PLO, staged a press conference to beseech mayoral respect — and an apology — for Arafat. Whenever Koch cries "fire" in such a crowded theater, he intends to steal some popcorn.

It is not so much Arafat, but Koch himself, that the former Democratic mayor feels has been too long slighted. After crossing over to endorse this Republican Giuliani for office, Koch has not seen enough of his cattle allowed at the trough.

Arafat was but a handy, albeit odd, stick to get Giuliani's attention. Neither the chairman nor the former mayor, however, is likely to get an Giuliani apology.

The mayor has shown, if nothing else, that the office does not change the man. Such positive traits as decisiveness, intelligence, hard work and discipline that allow an elected official to solve the complex problems of an administration are exhibited long before he is elected. So too are those negative traits that can canker the healthy tissue of an officeholder's achievements.

During City Hall crises, every negative trait that we learned from good sources about Giuliani has sprung forth. His law partners and associates worried that he lacked the temperament to be the mayor of this large, cosmopolitan city of multinational diversity. In a *New York Times* campaign story, Giuliani associates warned that the mayoral candidate was authoritarian, thin-skinned, overzealous, too provincial and self-righteous.

Provincialism likely triggered the mayor's authoritarian impulse to override U.S. protocol and eject Arafat. Just as likely, his self-righteousness prevents him from seeing this discreditable stunt as anything but an act of high grace.

In both cases, New Yorkers, who were forewarned, deserve this mayor careering headlong toward the edge, all cylinders clicking — with no brakes.

Same old song and dance

"Women, if you won't press charges, don't complain about being raped. Women, if you won't stop letting men into your apartment, don't complain about being raped. Women, if you won't quit going to bars, don't complain about being raped. Women, if you won't stop wearing those mini-skirts, don't complain about being raped."

Are you seeing a pattern here? It's the same old song and dance. Women have to live up to a certain set of expectations before they're allowed to rage at the violation of their souls. In the past, they had to be "good" girls. They had to wear the right thing, go to the right places and behave the right way. Now it appears, at least in the opinion of Jeff Hickman, that if they must consent to a rape by the system in order to legitimize the rape of their body.

Let me tell you something about the court system, Hickman. It may be prepared to deal with the psychopath that ambushes an old lady taking out her trash, throws her on the gravel and violates her, but it doesn't have a clue what to do with Joe-Cool college student who just didn't get the message in time. Contrary to your scenario, in a date rape situation, most perpetrators don't even realize that what they are doing constitutes rape — and most victims of rape aren't in a state of mind to immediately pick up the phone and report the crime. That could take days or weeks. For some it takes years.

Guess what that means? No physical evidence. Know what? No physical evidence usually means no case. That makes it her word against his, and most prosecutors won't accept the case.

For some women, pressing charges is not possible. And for others, it takes every bit of strength and courage they have to make that first phone call, and reporting the crime is the most they are capable of. Don't belittle these women.

It would be wonderful if every rape could be reported and prosecuted. It would be even better if it never happened at all. But until you've been in that situation; until you've walked a mile in the shoes of a woman who feels responsible for what happened to her because society makes her feel that way; until you've experienced this kind of violation to the essence of your being, don't begin to presume to tell these women when they can and cannot complain about what they've suffered.

The truth and facts of how Moose died are indeed tragic, but not to the extremes that have been seen.

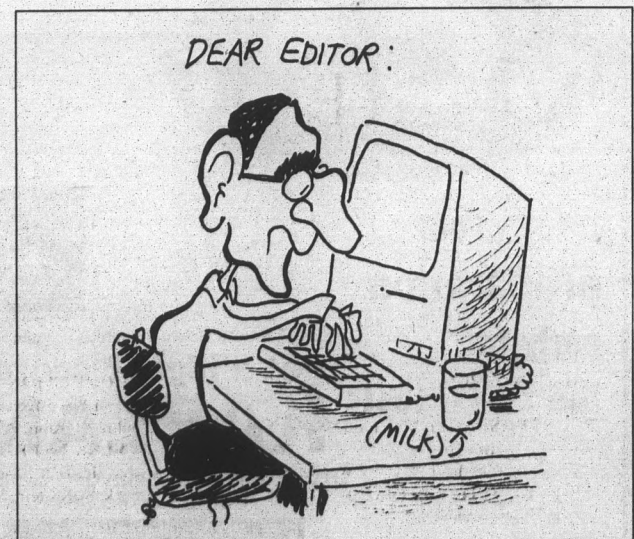
Oct. 20 is the date that the dog was allegedly poisoned. It is now Nov. 2 and there are still news articles on the subject.

Trick or Treat?

Officer in clown costume arrests 12

PAULSBORO, N.J. (AP) — A police officer who went trick-or-treating as a clown on Halloween bagged a dozen fugitives.

"They can't believe it," Lt. Tom Sullivan said. "They've been had."

Most of those arrested — who faced mostly routine traffic charges — responded good-naturedly. One was peevish: "Man, you got me under false pretenses," Police Chief Kenneth Ridinger said.

Some at the police station were a bit more upset.

"I think it sucks," said Cindy Hughes, handcuffed and arrested for an outstanding traffic ticket after the clown at the door asked for her.

The costumed visitor Hughes thought was a friend was actually Officer Craig Kraemer. Wearing a bulletproof vest under his costume, Kraemer called out "Trick or treat!" at each house and asked for the person named in the warrant.

The tactic made a dent in a stack of 400 outstanding arrest warrants, including one person facing a firearms charge and another accused of smashing a car's windows while a child was inside.

"You get an opportunity to go in unsuspected," Ridinger said. "We don't get the standard police answers. You don't get a 'He's not home.'"

Though most fell for the ruse, a teen-ager recognized Kraemer at one house.

"He got stopped at the door," Ridinger said. "We lost the element of surprise there."

Police were not looking for that teen, and no one was arrested.

One mother said she was not angry, just upset that her children witnessed her arrest — could they ever trust a clown or a cop again?

Patrolman Fred Suter came up with the idea two years ago, and went out as Batman. He made about four arrests that time.

Ridinger has no plans to send his officers out every year. He wants to keep the element of surprise — and the good will of the town's youngsters.

"If we do it every year, everybody will start shutting their doors and the poor kids can't get their candy," the chief said. "We don't want to infringe on that."

Super Bowl to draw more snowbirds

Students say winter visitors on the road cause traffic problems

Traffic is bad enough for Tifney Green without winter visitors flocking to Tempe.

"They're annoying in traffic," said the senior psychology major regarding the hordes of winter visitors, or snowbirds, who come to Arizona each year.

Green cited slow-driving habits and wrong turns as some problems snowbirds bring to Tempe.

"You have to be more careful when you're behind them," she said.

The number of snowbirds in Tempe has increased steadily for the last three years and will jump sharply this year because of the Super Bowl, said Aimee Fantazier, communications membership manager with Tempe Convention and Visitors Bureau. Although she said the Visitors Bureau does not calculate the number of visitors Tempe receives, about 150,000 out-of-staters should arrive in Tempe for the Jan. 28 Super Bowl and related activities.

Fantazier said the increase of winter visitors will be highly visible on the roads between early and mid-November.

"The number of vehicles, particularly in a metropolitan area that doesn't have a real strong public transportation system, is definitely felt," she said. "There's going to be

more cars fighting for parking spaces."

The impact snowbirds have on the streets can be dangerous, said senior justice studies major William McDonald.

"They're a hazard," he said. "Most of the time they're driving their Winnebagos and campers, and it obscures their vision so bad they can't view traffic around them and ... makes it dangerous for everyone else on the road."

Sgt. Toby Dyas, public information officer with the Tempe Police, said some traffic problems do result from snowbirds, but there is not a great increase in traffic accidents or tickets during their stay.

"There are some people who have problems adjusting to driving in a city this size if they're from a smaller community," he said.

In addition, Dyas said drivers unfamiliar with the area will drive too slowly or turn from the wrong lane. However, he said anyone unfamiliar with the state he or she is driving in can have these problems.


Dyas advised that people driving behind snowbirds have patience to avoid accidents and traffic violations.

"Practice good defensive driving techniques," he said. "If you're not sure if someone's turning, slow down and make sure what they're going to do before you pass them or pull out in front of them. Don't trust turn signals."

Islam, told a Nation convention that President Bush "played a leading role in developing a policy of genocide against non-white people all over this earth, and we believe that the AIDS virus is a direct consequence of that plotting and planning in secret."

Quinn and her colleague Stephen B. Thomas of Emory University in Atlanta have previously found the conspiracy belief to be widespread among blacks in Washington housing projects and clinics and among black college students.

"In all of these samples, somewhere around 30 to 35 percent are agreeing that AIDS is a form of genocide and 30 percent are unsure," Quinn said Tuesday in an interview at the annual meeting of the American Public Health Association, where

she reported the findings.

Quinn and Thomas gave a questionnaire to 1,054 church members in black churches in Atlanta, Charlotte, N.C., Detroit, Kansas City, Mo., and Tuscaloosa, Ala. They received slightly under 1,000 valid responses for each question.

Asked to react to the statement "I believe there is some truth in reports that the AIDS virus was produced in a germ warfare laboratory," 33.9 percent of 983 agreed or strongly agreed. Forty-four percent were unsure.

Thirty-five percent of 979 agreed or strongly agreed with the statement "I believe AIDS is a form of genocide against black people." Thirty percent were unsure.

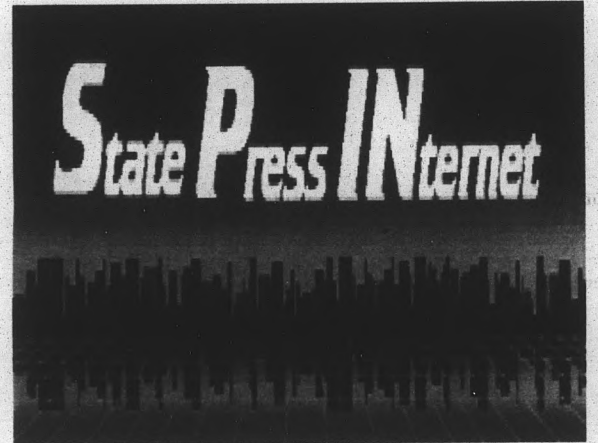
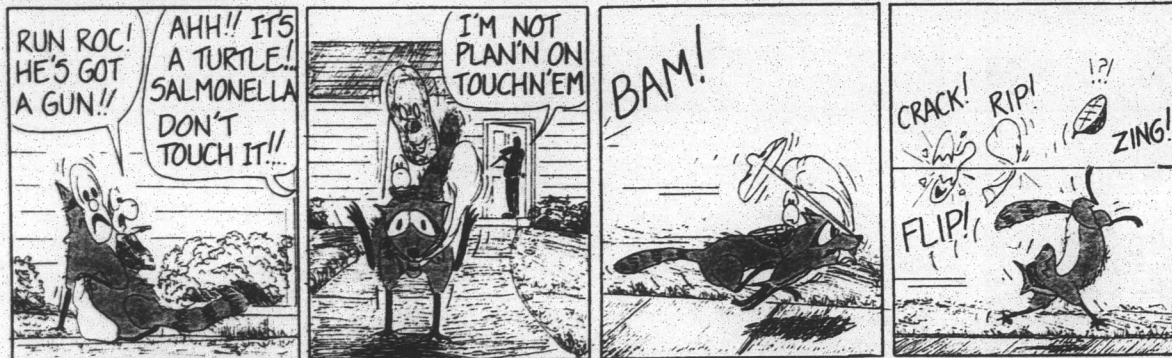

'KARIM' FOR A DAY

ASU tailback Farlow imitates UCLA's tailback Abdul-Jabbar

Living up to Heisman Trophy candidate status can be a difficult task, but trying to copy his every move can be just as difficult as scout team running back Marlon Farlow discovered.

Farlow has been playing the role of ASU's next nemesis, UCLA running back Karim Abdul-Jabbar, in practice this week. Farlow, a sophomore who is redshirting this year, will try to get the Sun Devils first-team defense ready for Saturday's game.

"We just have to get him running and see if we can get him tackled," Head Coach Bruce Snyder said of Farlow, who is 5-foot-10, 195 pounds. "They have very similar size. They're spitting images of each other that way. I don't think we could've got any better because he's very similar."

Ron English, a graduate assistant coach who assists with preparing the defense, said, "We want to give our defense as close a look or simulation that UCLA has to offer."

Abdul-Jabbar, who is 5-10, 197 pounds, leads the Pac-10 in rushing — by far — with 1,212 total yards, a 5.2 yards-per-carry average. He also has 10 touchdowns and averages 151.5 yards per game. The ASU coaching staff is more than a little concerned with the task at hand.

"The guy's a hell of a running back," English said. "He's probably the best running back we'll see all year. He makes them go. You stop him, you stop the Bruins."

Farlow added that Abdul-Jabbar is a legitimate candidate for college football's highest individual honor.

"He's been running hard these last couple of weeks since I've been watching him. He's averaging almost 200 yards a game," Farlow said. "That's a lot of numbers. He could be up there for the Heisman."

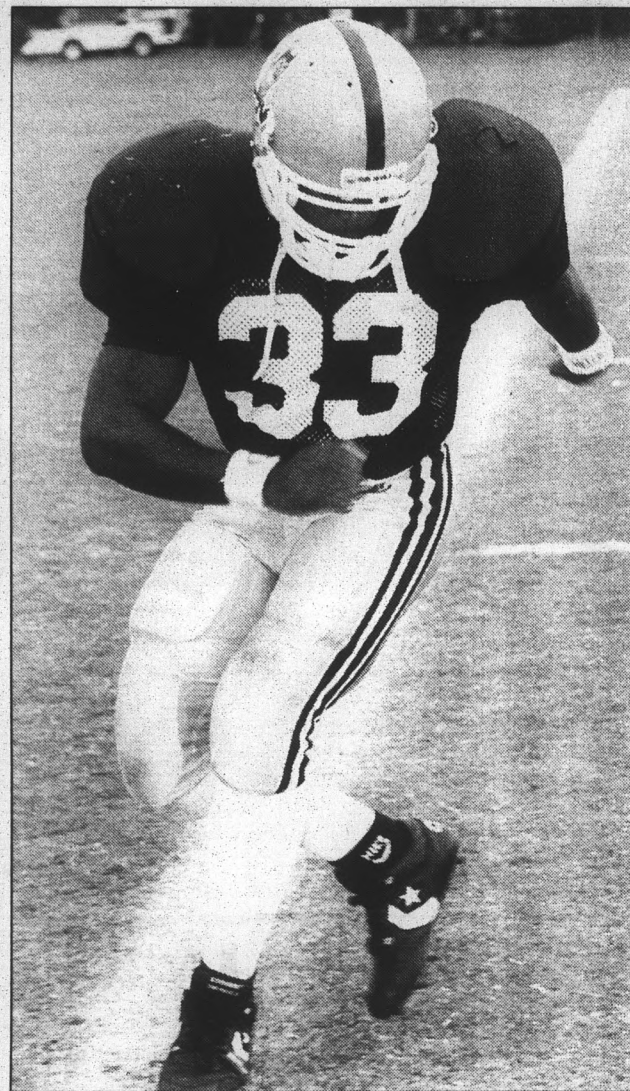
Farlow's task of mirroring Abdul-Jabbar began this week with him watching film of Abdul-Jabbar everyday. English and Farlow studied Abdul-Jabbar's moves and tendencies as a runner.

"When I look at him, I see a Walter Payton style," Farlow said. "High knees, pumping his legs all the time (and) great cuts. He's an unbelievable runner. Sometimes he just makes moves that you can't believe he makes."

Added English: "He's decisive. As he makes a decision, he goes with it and then he has real good feet. The first guy hits him and he's running out of that tackle. The second guy hits him, and he's running out of that tackle. He likes to get up field. He's always gaining positive yardage."

After reviewing the film of Abdul-Jabbar, Farlow will try to apply and copy his style.

"What Karim Abdul-Jabbar likes to do is run north and south — to use coaching terms," English said. "This week I'm telling Marlon, 'I want you to run straight up the field (and) get up the field,' (and) that's what he's been doing."

Farlow said the films help, but it's almost impossible to completely copy Abdul-Jabbar in practice.

"It's pretty hard to try to make all the cuts that he makes, have his eyes and his vision," he said of Abdul-Jabbar. "He has great vision. You really can't take his moves. You can watch him on film

and do the best you can. When you go out there, it's hard to make those decisions he makes.

"Everyone has a different style of running as a running back, but I can almost get him down, almost."

English said having a great athlete like Farlow makes the adjustment much easier. Farlow, in fact, played in nine games last year as the Sun Devils' fourth leading rusher with 179 yards on 62 carries for a 2.9 yards-per-carry average.

"It can be tough depending on what kind of athlete you have," English said. "If you have a great athlete, then I think he can pretty much emulate anyone's style. The difference is in the body types of guys. Let's say you

have a smaller guy like Marlon and you want him to become a big guy. That's impossible for him to become a big guy. That's

when you run into problems."

Farlow's mimicking of Abdul-Jabbar has also included wearing Abdul-Jabbar's No. 33 jersey in practice.

"Everybody on the team is calling me Karim," Farlow joked.

On the practice field, the Sun Devil defense treats Farlow like an opposing player until the whistle blows.

"They send out the licks and I send them back, but they pick me up when they hit me hard," he said. "That wouldn't happen in a game. I hope it wouldn't. They don't need to be picking those guys up. They hit me just as much as they would on Saturday."

Farlow said he doesn't mind playing different roles every week in practice.

"It's exciting to see what number I'll be wearing every week," he said. "Last week I was (Oregon tailback Ricky) Whittle. It's exciting trying to study them, see how they run, see how they tough they run and try to be like them. Then I just go out there and use my basic instincts, use my vision and eyes that I have out there and go out there and run."

Things weren't always this good for Farlow. He struggled with his adjustment to the scout team initially. Farlow had hoped to receive a lot of playing time at the tailback position this year, but the coaching staff decided to redshirt him because of the logjam of running backs.

"It was a shock to me, but I dealt with it," Farlow said. "I felt hurt by it, because I felt I was running well. I didn't know what it was that caused me to redshirt."

Farlow began to question his own abilities after he was assigned to the scout team.

"I thought this would be my year to shine or get my chance to show what I can do," he said. "I was kind of down on myself because I was thinking maybe I'm not good enough to go out there and get the job done. That's probably why they're redshirting me, but I don't think that was the case."

Snyder said he understands Farlow's difficult transition and has been very pleased with the way he's handled it.

"Sometimes its hard on guys to red-shirt," he said. "It's a psychology thing. He's taken it very well. He understands he can get better because of it."

Farlow added the coaching staff hasn't given him any specific reasons for the move.

"I've never got a real legitimate answer from the coaches why I'm redshirting," he said. "It was just, 'You're redshirting, you're on the scout team.' Everyday I'm getting better and better. Still, if I don't get a chance to showcase what I can do, those three years (of eligibility) won't mean anything."

Snyder said just because Farlow had to redshirt does not mean he isn't part of the future plans.

"Obviously, we felt there were too many guys in the same class and with (Chris Hopkins) being a senior, somebody should redshirt," Snyder said. "We wanted to red-shirt someone who was obviously very talented because he might be the back of the future. That would give him another year."

Now, two months after he was told of his status, Farlow sees this year's move as a benefit.

"I think it's helped me a great deal — this year of sitting out (and) redshirting," Farlow concluded. "I'm taking advantage of it. I'm in the weight room working out, getting a little better feet (and) running against the number one defense that's going to be out there on the field Saturday night."


Farlow said next year he hopes to show his true self on the football field.

"When it's time, I'll be wearing the No. 4 jersey which is my real number at Arizona State," he said. "I'll show what I can do if I get a chance. (Number 33) is only a temporary number. It's no big deal."




