3 students critical after van accident

Students, faculty and staff are concerned about the three students who remain in critical condition after being injured in an automobile accident Saturday morning.

"We are greatly concerned for the students who were in the accidents, and also for their families and friends," said Milton Glick, provost. "Everyone is hoping that they all come out of this."

The accident occurred at about 9:30 Saturday morning when an ASU van, carrying eight students and a staff member, collided with a light pole and overturned on Interstate 17. The students were members of the ASU Geographical Society and were on their way to the Cyprus-Bagdad open-pit copper mine near Wickenburg. Four passengers were flown to local hospitals, three were transported by ground and two were treated and released at the scene.

Jonathan Triggs, 21, fractured two fingers, suffered several gashes in his scalp and lost some teeth.

The accident occurred when the driver of the van missed the Carefree Highway exit.

"She turned the wheel to try to make the exit and the road was wet," Triggs said. "(The van) spun in the other direction."

"I was ejected through the window but I was still in the seatbelt. The van was upside down, I was still attached via my seatbelt but my upper body was outside the van."

Triggs said he was face down on the pavement and paramedics had to help

him out of the van. He was flown to a local hospital where his condition was downgraded to serious. Triggs was released on Sunday. Even though Triggs is out of danger, he is still worried about the others who were hurt.

"I know I am going to fully recover from my injuries," he said. "I'm just really concerned about everyone else. I'm definitely going to keep them in my prayers."

Harold Donaldson, 51, was also a passenger in the van but said he doesn't remember much of what happened.

"I just remember going out of control, spinning around and a light pole coming towards me," said Donaldson, who fractured a collarbone. "Next thing I know, I was in the rear seat and on the ground."

Staff member Evelyn Partridge, 64, and students Matthew Bailey, 29, and Helga Dunn, 39, remain in critical condition at area hospitals, said Arizona Department of Public Safety

Officer Pete Borquez.

Dunn is in intensive care with little change in her condition, said father-in-law Norm Dunn.

"This is a terrible tragedy and it's a tragedy for all concerned," said Wendy Wilkins, associate dean of the College of Liberal Arts and Sciences. "We're trying to find out how the people closest to the victims can best be helped."

Numerous calls were placed to the Geography Department but Chair Breandan O'hUallachain refused to comment.

Funds take back seat in renovation campaign

The colleges of Fine Arts and Public Programs and the campaign to renovate Old Main are coming to the forefront of the Campaign for Leadership as they find volunteers and raise millions of dollars — and they attribute it all to who they know.

"They have really engaged partners in the community," said Becky Cole, chief operating officer for the ASU Foundation, a development office at ASU. She introduced

the three smaller campaigns as profiles of the success of the overall \$300 million Campaign for Leadership at the National Campaign Cabinet meeting last week.

Fine Arts has raised about \$9 million of its \$17 million goal, and Public Programs has raised about 60 percent of its \$12 million goal. The restoration of Old Main has raised about 80 percent of its \$5 million goal.

But the success of the two colleges is not solely based on numbers, said Lonnie Ostrom, director of development and

president of the ASU Foundation.

"It's not just the numbers you raise, it's the relationships you build," Ostrom said. "They have their leadership committees, the campaign committees that are really involved. They've identified and involved a lot of volunteers and prospects for the campaign."

"There are 300 reasons why the College of Fine Arts is a success," said Bob Wills, dean of the College of

Cultural understanding goal of theater project

ASU Public Events is teaming up with The American Festival Project and several diverse campus organizations to help eradicate stereotypes and discrimination using theatrical performance and storytelling.

The project aims to educate students and community members about different cultures and how they originated.

"Theater is a wonderful way to convey our message," said Andrey Hernandez,

outreach and education coordinator for ASU public events. "We put this project together to break down barriers and stereotypes while learning about one another to create less antagonism."

Hernandez said the idea initially formed years ago after racial misunderstandings occurred on campus. The theme, "Untold Stories: Celebrating Campus and Community," tries to connect communities using art and performance as primary keys for education, she said.

"I don't think people take the time to learn about who people are," she said. "This will allow the community to tell their stories and give people the opportunity to visualize different cultures."

Bonnie Eckard, chair of the Theater Department, said the events will bring artists from all over the country to ASU which helps make the project worthwhile.

"It's a very exciting project to reach out into the community using theater to make other people's lives better," Eckard said.

"There is a stress on social responsibility to enrich cultural education and build theater."

The campus groups paired with The American Festival Project because its theme is exploring and celebrating cultural exchange based on equality and mutual respect, Hernandez said. The theater groups, which consist of 10 multicultural theater companies, began in 1982 in response to a national increase in Ku Klux Klan activity.

The project includes ASU's African-

Fine Arts, in reference to the 300 people who helped with Fine Arts events and programs last year.

Personal relationships are where success lies, Wills said.

"We try to raise friends rather than funds," he said.

"We are grateful for \$1 million, and we are grateful for \$100 gift," he said. "We try to treat friends equally."

Wills said the college tries to be a good steward of the money it raises from the Campaign for Leadership and be a good resource of the community. The very nature of a Fine Arts College means the public knows what the students are doing, he added.

"They see it on the stage or in the gallery," he said. "They see the kind of success the students can have. People like to give to success and to excellence."

Nancy Dean, development officer for the College of Public Programs, said the college's campaign success comes from the bridges it builds to the community.

"All of our programs have strong relationships with community," she said. "It's also the opportunity to create new relationships."

She said the college uses the talents of its volunteers where they are best suited. Volunteers also help the college identify new community partners.

"It's really all about people," she said.

Dean said the college had raised 40 percent of its goal when Public Programs held a kickoff in November. The college has raised another 60 percent of the goal since then.

"That just shows the progress between then and now," she said.

Grady Gammage Jr., co-chair of the campaign to restore Old Main, said there were six reasons why the renovation campaign has been

so successful. He called attention to the "enthusiastic" board of directors, "great and active" campaign committee, the "largest single group" of campaign volunteers in the whole campaign, continued publicity from the alumni magazine, large gifts, and "the appeal of history" to the University.

"With the success of Old Main we hope can be an example for the rest of the campaign," Gammage said.

The other units raising money in the Campaign for Leadership have not made the leaps and bounds of the other three.

The College of Extended Education's goal has acquired about 10 percent of its \$2 million goal, said Scott Sheldon, director of development for the college.

"We don't have faculty or alumni, we have to go to the community," he said. "We're very happy with what we've done so far, but we're certainly not the leader of the pack."

Jack Greenwood, new development director at the College of Law, said the college didn't have a director for seven months.

"I know we're behind most of the efforts of the other colleges," he said. "We don't really have a strong volunteer organization at the College of Law yet."

The Honors College is paying attention to a couple different projects, said Melissa Warner, development officer for the University Honors College.

"The honors college is kind of in an unusual situation, we're raising money for the college for projects, and we're also looking for a name for the endowment," she said.

U.S. to deploy up to 3,000 ground troops to Kuwait

AL-JABER AIR BASE, Kuwait — The Pentagon is sending up to 3,000 troops to Kuwait — tripling U.S. ground forces in the country — “to discourage any creative thinking” by Iraqi leader Saddam Hussein.

At the same time, Secretary of State Madeleine Albright ruled out any massive military invasion of Iraq. “The administration does not agree with those who suggest we should deploy hundreds of thousands of American troops to engage militarily in a ground war in Iraq,” Albright said in a speech in Washington.

The latest deployment of U.S. ground forces was disclosed by a senior military official traveling in the region with Defense Secretary William Cohen. He said up to 3,000 troops from Fort Hood, Texas, will be sent to Kuwait over the next 10 days or so to help defend Iraq’s southern neighbor.

“The purpose is to ensure the security of Kuwait,” the official said, speaking on condition of anonymity. “It’s to discourage creative thinking on (Saddam Hussein’s) part.”

Although Cohen had not formally signed the deployment order, a Pentagon official said Monday “the forces have been requested and that request is being considered and processed.”

They will join 1,500 Army troops who have been using M1-A1 tanks, armored Bradley troop carriers and other vehicles during a scheduled exercise in the desert emirate. The United States deployed 541,000 ground troops during the 1991 Persian Gulf War.

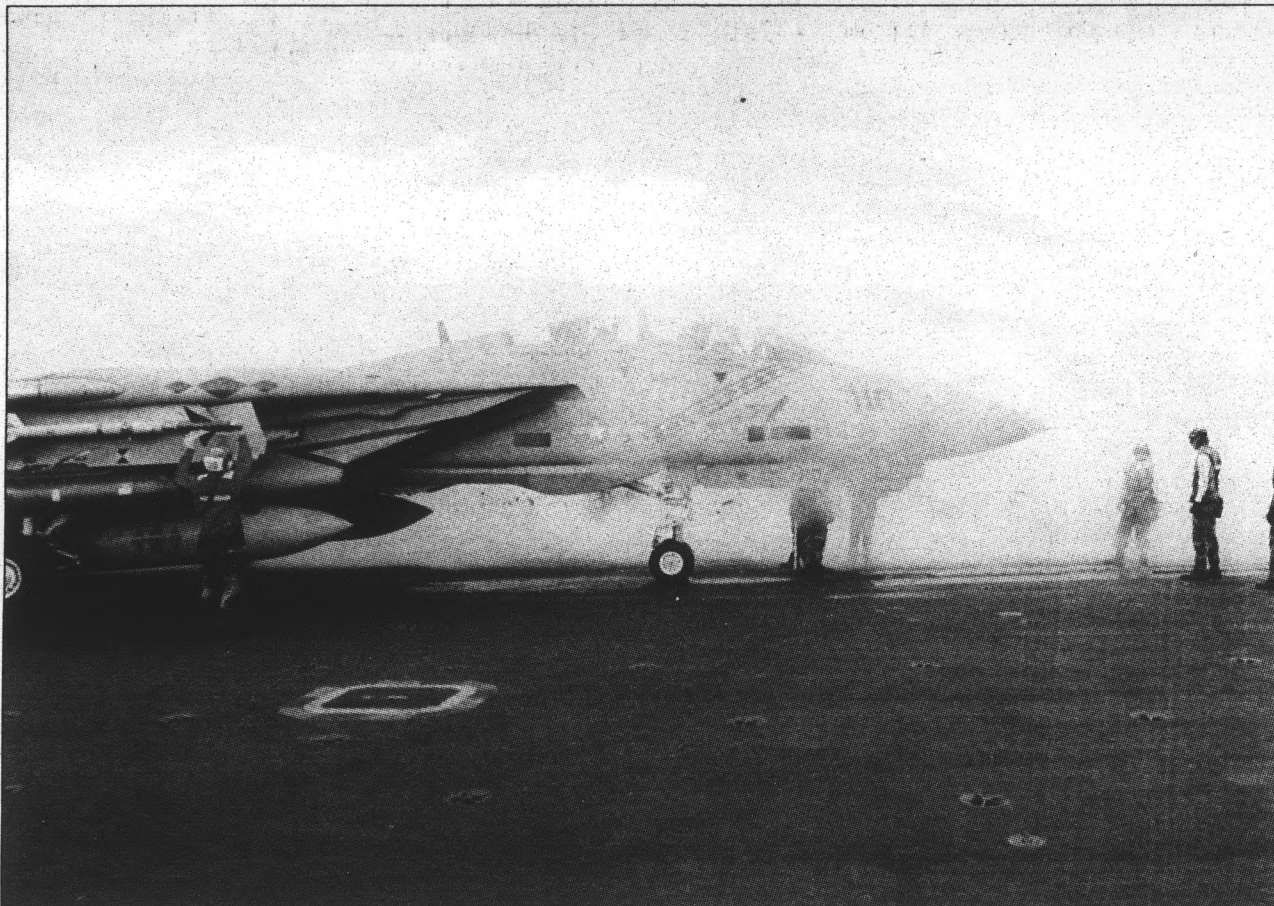
The armored vehicles were stored in Kuwait after the Gulf War and have been used repeatedly by U.S. troops in training exercises.

For its part, Iraq appeared to be preparing for a U.S. attack. Troops of Saddam’s elite Republican Guard, for instance, were being scattered throughout the country in an effort to ensure that his government remains in power, according to Iraqi travelers arriving in Jordan.

Iraq also dispatched diplomats to several Arab countries that joined the U.S.-led coalition in the Gulf War, seeking their support.

Cohen flew about 50 miles outside Kuwait City on Monday to visit this desert air base, which is surrounded by the broken and bombed-out remains of concrete bunkers hit by U.S. strike aircraft in 1991 after the Iraqi invasion.

“You are the best and the brightest America has to

offer,” Cohen told the crowd of mostly U.S. Air Force men and women. “You are great warriors and diplomats.”

Walking through the crowd, the former senator from Maine told them, “It’s important to look at your faces so when I sign a deployment order I take into account those faces.” The defense secretary spent nearly an hour handing out special medallions and posing for photos.

“We’re locked and loaded,” said Col. James Coning, a deputy commander for Air Logistics with the Ohio

National Guard, who turned out to hear Cohen. “Just let us loose.”

Buck Buckingham, an F-16 pilot from Denver due to return home in a week with his unit from the Colorado National Guard, said he would be disappointed if military action was ordered after he left.

“Not that we want war, no,” said Buckingham. “We’re trained to protect the United States, and we want to be able to do what we’re trained to do.”

Storms cause 13 deaths in Tijuana, flooding in California

TIJUANA, Mexico — Soldiers and rescue workers scraped away mud and debris Monday after El Niño-fed floodwaters roared through a border shantytown, killing 13 people and forcing hundreds to flee their homes.

Three teen-age girls were killed after fast-flowing mud swallowed their family’s car at the foot of the eastern shantytown of Mexico Lindo, or Beautiful Mexico.

Some 500 people took refuge at shelters because their neighborhoods were buried in mud, water and debris.

North of the border, Californians took advantage of a break from the storms that have battered the West Coast for a week. They cleared roads, cleaned catch basins and drains and rebuilt sandbag barricades. Sunshine bathed Southern California, which saw up to 2 feet of rain in some areas.

Forecasters said the next storm was expected to blow ashore farther north Monday night,

with the brunt of the bad weather hitting Oregon and Washington state.

But California was still far from drying up. Seven-foot waves coupled with a 6-foot-high tide pounded San Clemente beach homes and ate away 100 feet of sand at Broad Beach. The nearby beach retreats of Steven Spielberg, Danny DeVito, Frank Sinatra, and others weren’t threatened, but one Malibu home was destroyed and four others were seriously damaged.

In San Clemente, resident Greg Rhys piled sandbags only to see the sea carry them away.

“There’s nothing you can do. I’ve given up on the front of my house,” neighbor Al Lundberger said as still another huge wave crashed against his beach house.

In Northern California, the waters of the state’s largest natural lake crept higher and threatened homes along the shore of Clear Lake. Five hundred families were forced to flee.

Another major Japanese bank implicated in bribery scandal

TOKYO — With the scandal in Japan’s financial sector spreading, a former official of a leading bank was arrested Monday on suspicion of bribing finance officials with lavish hospitality.

Prosecutors arrested Kozo Umezu, 57, a former executive of the Industrial Bank of Japan, on suspicion of bribing a director of a highway company in exchange for being chosen to underwrite the company’s bonds, a bank spokeswoman said.

Several other IBJ executives were also questioned.

The action comes as a series of financial scandals

have highlighted the conflict between Japan’s loosely enforced laws and its traditional forms of government-business collusion.

Last month, two Finance Ministry officials were arrested and accused of being wined and dined in return for tipping banks off about “surprise” inspections.

That scandal brought down the finance minister and his deputy. It also has shattered the powerful ministry’s image as unquestioned custodian of the economy with news reports of lavish dinners and sex parties.

In a related case, the Bank of Japan, the central bank, announced it will investigate whether its employees have accepted any influence-peddling entertainment

from commercial banks.

The decision followed a report Saturday by the national newspaper Yomiuri that two Bank of Japan officials were treated to dinners and other entertainment worth more than \$32,000 over the last five years by commercial bank executives.

The investigation will cover about 600 current and former officials in their dealings with private sector bankers, the central bank said.

The central bank’s action follows a similar investigation by the Finance Ministry into the conduct of about 550 of its officials in the wake of its own bribery scandal.

'Titanic' holding steady at box office, awards

The unsinkable movie about the sinkable ship may be getting a boost today.

But judging from its current box office success, *Titanic* won't really need it.

By day's end, the James Cameron film starring Kate Winslet and Leonardo DiCaprio will be handed an unnecessary life preserver when nominations are announced for the Academy Awards.

While critical acclaim is always pursued in the film industry, so are dollar bills. An Academy Award nomination would almost be redundant, since *Titanic* doesn't appear to be slowing down soon.

Currently the movie has grossed \$337.5 million in its initial release, making it the No. 4 all-time domestic moneymaker. The film raked in an estimated \$23.2 million this weekend, beating out *The Replacement Killers*, starring Mira Sorvino and Chow Yun-Fat.

Even the critical accolades *Good Will Hunting* received have not been enough to challenge *Titanic*.

If, as expected, *Titanic* is nominated for a number of Academy Awards, then expect interest in the film to surge as slackers who have yet to see the film juggle their schedules to see the 3 1/2 hour-long epic.

At the rate *Titanic* is sailing in the box office, it may be poised to upend *E.T.* and *Star Wars*, the No. 1 and 2 all-time big grossers, in a month or two.

But don't expect *Titanic*'s challengers to sit idly. *The Wedding Singer*, the romantic comedy starring Drew Barrymore and Adam Sandler, is expected to do well during its opening weekend — which, appropriately, is Valentine's Day weekend — but is still a longshot to dethrone *Titanic*.

The April release of *Lost in Space* could give *Titanic* some competition, but it's unlikely to capsize it.

If *Titanic* can ride into May still in the top spot, it will have to face *Godzilla* — expected to be the blockbuster of the summer — on May 8, along with *Armageddon* on July 1.

So with or without an Academy Award nomination, *Titanic* relatively calm waters going into the summer movie season.

It's almost not fair: All this hoopla for a movie whose ending we already know.



Noble traits reminisced on Lincoln's birthday

Feb. 12 marks another birthday anniversary of one of our most-distinguished presidents. He is well remembered by the greatness of his Gettysburg Address, but there were other admirable qualities about him.

Today's ground-floor Oval Office did not exist in Lincoln's White House. The second-floor room now identified as the Lincoln Bedroom was the president's office. Here Lincoln read his mail, wrote letters and did the routine office work such as filing documents. Here too, for five hours a day, two days each week, Lincoln greeted scores of visitors personally.

These were not invited guests. They were the general public who wanted to see and speak to the president personally. They would line up outside for hours, if necessary, to plead for jobs, air their grievances, ask for favors or offer suggestions on how to better govern the nation. But Lincoln seldom complained about this grueling task. He considered these sessions "public-opinion baths," and that is how he sampled his larger constituency.

Lincoln considered himself an ordinary person and certainly no better than the people he governed. He was also a bit shy and reserved, seldom "pushy." A good example of Lincoln's reserve was the preparation for the ceremony to be held at the Gettysburg Cemetery. President Lincoln was not scheduled to be the principal speaker. That honor was for Edward Everett, the great orator of the time. As a result, Lincoln wrote a short two-minute address, which we remember by the opening words "Four score and seven years ago."

On the day that Lincoln departed for Gettysburg, he had no idea that he was to deliver a memorable speech that would be remembered for more than 100 years, a speech that would be memorized and delivered by school children over and over again. Lincoln was light-hearted, jovial and relaxed. So relaxed, in fact, that his aides had

to push him to get started for fear that he would be late for the ceremony.

Everett delivered a long and learned oration with brilliance. The crowd of 15,000 listened intently to the great orator, and they applauded appreciatively for a long period of time. Then after the singing of a short hymn, Lincoln rose to give what was intended to be a short address to dedicate the cemetery. But he had prepared the 272-word speech carefully and solemnly.

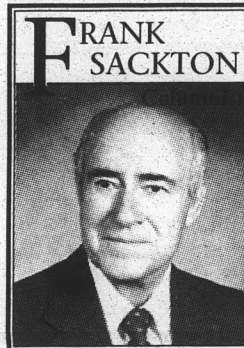
It wasn't only the wording of his address that captured the attention of the audience, it was the sincerity and passion. Utmost in his mind were the 51,000 union and confederate soldiers who had fought and died there, and the realization of what the war was all about. Lincoln was fighting for the nation's soul. That is why he alluded to "the proposition that all men are created equal," and that the aim of the war was to test "whether that nation or any nation, so conceived and so dedicated, can long endure."

The address ended. There was no applause. Lincoln's first reaction was that the address had fallen flat. It was much later that he learned the crowd had not applauded out of reverence. The audience, all 15,000, had experienced a touching and sacred feeling that could be appreciated only by silence and prayer. Lincoln's talk was not only a tribute to the dead, it was also an appeal to the righteousness of the war, that a nation that prized liberty "shall not perish from the earth."

After Lincoln returned to the business of the presidency, Edward Everett wrote him, "I shall be glad if I could flatter myself that I came as near to the central idea of the occasion in two hours as you did in two minutes."

Lincoln had underestimated the power of his address. Otherwise, he would not have included "the world will neither note nor remember what we say here, but it can never forget what they did here." But the world has remembered more of what was said by Lincoln at Gettysburg than the battle itself. And it will be remembered forever.

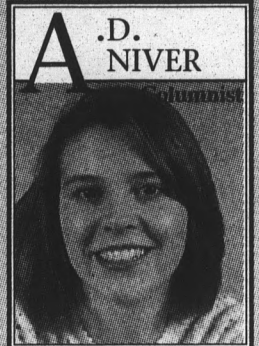

7-11 leading the way in health care

Among the many paradoxes that exist in American political concepts is the discrepancy between what is and what we want to be. President Clinton, Hillary and Congress all want Americans to have affordable health care. We do not want a socialized system of medicine, but it is the object of our government that medical facilities be available and affordable to all. This has traditionally been a problem left to the government and insurance companies.



If citizens do not have health insurance or an HMO available through their employer, they can purchase it if they are able to afford it. If they cannot afford insurance, they have the opportunity to get medical assistance from the Federal Assistance office closest to them. If they do not make enough money to afford insurance but make over \$4,500, the cutoff for eligibility in many states, then although they deserve affordable health care, they are left in the margins of economic assistance and availability. People requiring or desiring some form of medical counsel, treatment or surgery are accountable for the full sum of any medical cost incurred. Instead of a nice co-payment and a somewhat alarming monthly bill, which most health insurance companies require, these people are paying for the visit, the materials used during the visit, tests, x-rays and so on.

Those with medical assistance are not entirely better off. Their plight is one of constant irritation with a system that is trying to make their lives easier — vouchers that must be turned in at every visit (but come a month late in the mail), a possible co-payment made and limited choices for practitioners. These are some of the problems with HMOs.

But beside possible high prices and confusing paperwork (usually magnificently sorted through by the nurses at the check in/out desks), are the types of medical practices that are excluded. How many health insurance programs cover massage, holistic health, naturopathy, iridology, etc.? How many cover more-practical things like optometrists, chiropractors or even prescriptions?

But now, instead of the usual guys in the growing health business lending a hand to the middle man, there is someone new coming into the playing field — 7-11. This familiar convenience-store chain is giving its new concept a trial run here in Arizona. The Rx Benefit card offers up to 50 percent off prescriptions and eye wear. This may not sound revolutionary, but it is. This is putting health insurance into a market area with phone cards. The card has a limited usage for ninety days, but this only adds to the idea of a health-care assistance that you can get only when you need it.

Some people do not want to pay high insurance premiums, simply because they do not go to the doctor often and feel they will not be in an accident. Why pay good money for nothing? Yet preventative health care is the mindset many members of the health community want us to adopt. If all insurance was adjustable on a when-you-need-it basis, perhaps many things about it would become more endearing to the average single adult. Unfortunately, it would also become much more confusing to the accountants.

Private businesses, which notice and fill the gap for medical aid, should serve as an example for more businesses for a redirection toward more community serving, humanitarian products, programs and interests. A.D. Niver is a graduate student studying humanities.

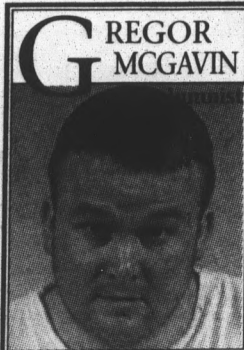
Ronald Reagan Parkway would have to be a toll road

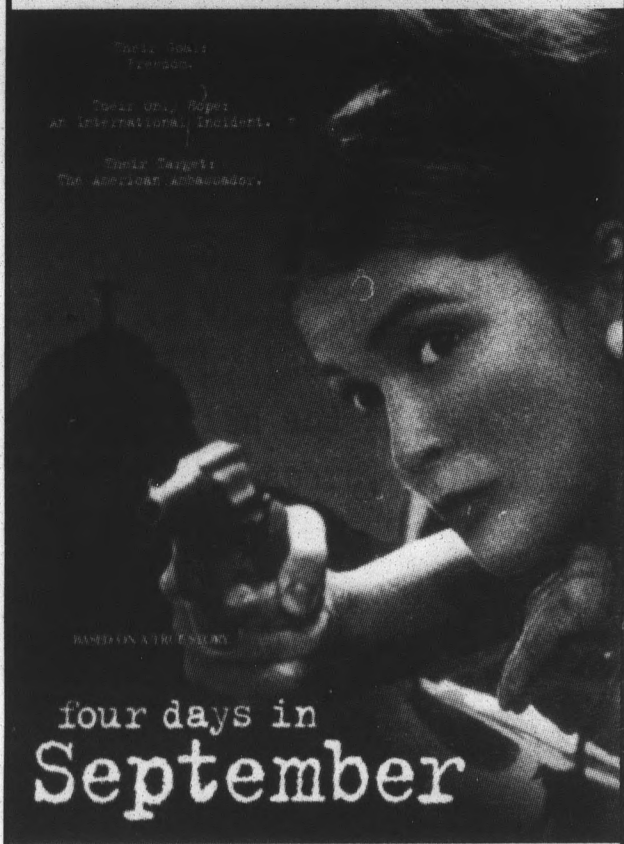

NBC may set price of a 30-second ad during 'Seinfeld' finale at \$2 million

NEW YORK — NBC may ask as much as \$2 million for a 30-second commercial on the final episode of *Seinfeld* — a figure that would break the record set just a few weeks ago by the network's Super Bowl broadcast.

The last original episode of the popular sitcom, slated for a full hour on May 14, is expected to attract a huge audience.

The trade magazine Advertising Age said in Monday's edition that NBC started floating the \$2-million asking price among media buyers last week and has no takers so far. The trade publication *Mediaweek* said media buyers were told NBC wants \$1.7 million to \$2 million for a single ad spot on the finale.

But Larry Hoffner, president of network sales for NBC, said Monday there had been no final determination on what NBC is going to seek for the last *Seinfeld*.

"We're not out in the marketplace with this right now, but we expect to be shortly — in the next week or so," he said. He said none of the nine to 10 minutes of commercial time on the last show had been sold yet.

NBC set the record for the most expensive commercial time only a few weeks ago when it raked in an average of \$1.3 million for 30-second commercials on the Super Bowl.

The game, which saw the Denver Broncos upset the Green Bay Packers for the National Football League championship, had an average rating of 44.5. A ratings point represents 980,000 households.

Seinfeld has been among the highest-rated series on TV in the past few seasons, with ratings this season in the low 20s. Hoffner said "we are looking at Super Bowl ratings" for the finale.

Commercial time in original episodes of *Seinfeld* this season have reportedly been going for as much as \$550,000 for a 30-second ad.

Hoffner also said the *Seinfeld* audience contains a large number of relatively affluent people who make the show the only prime-time program they watch regularly. He added that advertisers often pay extra to reach that type of viewer.

Jon Mandel, who oversees network ad purchases for the agency Grey Advertising, said the reported \$2-million asking price was designed to "get some headlines" and expects the real price will be lower.

But he said NBC will get a high price for the program, and it may make sense for an advertiser like a movie studio that wants "to do something that reaches the maximum number of people in the shortest period of time."

Officer accused of sex crimes called 'Jekyll and Hyde'

FORT BELVOIR, Va. — The Army's former top enlisted man was "a real Jekyll and Hyde" who used bribes, threats and emotional blackmail to pressure six women for sex, a prosecutor said in opening statements at the soldier's court-martial.

A lawyer for Sgt. Maj. Gene McKinney, however, questioned the truthfulness and motives of the six women and accused the Army of going after McKinney with a vengeance.

"This court-martial should cause every soldier grave concern," said defense attorney Lt. Col. James Gerstenlauer.

McKinney, 47, sat expressionless during the opening statements, his wife sitting behind him. He could get up to 55 1/2 years in a military prison if convicted.

McKinney told subordinates that he could help their careers and said that no one would believe them if they complained of harassment, the military prosecutor, Capt. Brian Dolan, said in his opening statement.

McKinney even invoked the death of his only child in asking one woman for comfort "in my hour of need," Dolan said.

"Sgt. Maj. McKinney was a leader who abused his power," Dolan told the jury of four officers and four enlisted men. The six women "saw the side of the sergeant major that everyone else saw, but they also saw a side most people don't see ... a real Jekyll and Hyde."

In one case, McKinney cornered a young sergeant in his private office at the Pentagon, telling her he had the power to help her career, the prosecutor said. McKinney grabbed the woman, ground his pelvis into her and told her "you're what I

need right now," Dolan said.

Gerstenlauer said there were plausible explanations for many of his contacts with women, disputing the prosecutor's version of events with the same refrain: "Bottom line: It didn't happen."

Gerstenlauer said McKinney has an alibi for the most sensational charge, that he had sex with a woman who was eight months pregnant, and questioned whether the sex act was physically possible as the woman described it.

McKinney took special care to help soldiers, including women, and was a devoted family man, Gerstenlauer said. But McKinney could be a tough boss and let it be known he was disappointed with the performance of his first accuser, retired Sgt. Maj. Brenda Hoster, who vowed revenge, Gerstenlauer said.

Defense begins its case in murder trial of former naval cadet

FORT WORTH, Texas — Lawyers for a former Naval Academy midshipman accused of killing a 16-year-old romantic rival tried to show Monday that blood stains at the scene indicate she lied in a written confession.

Edward Hueske, a forensic expert, testified that splattered blood on the thighs of Adrienne Jones could suggest she was carried to the field where her body was found.

"It is possible that she was carried. The blood on her legs is consistent with quite a bit

of handling of the body," Hueske said.

Diane Zamora's confession in the 1995 slaying stated that Jones escaped from Zamora's car through a passenger window and fled to the nearby field, where she ran into a barbed wire fence and collapsed. The confession didn't mention that Jones was carried.

Based largely on the confession, prosecutors contend Diane Zamora, 20, helped then-fiancee David Graham kill Adrienne Jones because the two had a fling.

Graham will be tried separately later this year. Both could face life in prison.

Hueske conceded under cross-examination that the blood on Jones' legs could have also come from her hands, which photographs show were covered in blood.

Prosecutor Mike Parrish asked Hueske if she "could have touched herself in escaping out the window of a car."

Hueske replied, "It is possible, yes."

A gag order has kept attorneys from revealing whether they will put Zamora on the stand.

Defense attorneys are trying to use possible discrepancies between evidence and

Zamora's confession to show she was lying in the confession.

The confession is crucial for state attorneys because they're prosecuting Zamora under the "law of parties," a statute that makes any accomplice to a crime guilty of the worst offense committed in its commission.

Both sides agree that Graham allegedly fired two fatal shots at Jones, but prosecutors have used the confession and other evidence to show that Zamora helped by hitting Jones over the head and by telling Graham to shoot her when she fled.

Freud regularly broke own rules about psychoanalysis

NEW YORK — Was Freud a Freudian? Maybe not.

A study of what went on in that famous office in Vienna says Sigmund Freud routinely broke three of the major rules he laid down for how to conduct psychoanalysis.

Those rules: Keep the sessions confidential, don't give advice and don't reveal anything personal about yourself to the patient.

Dr. David J. Lynn, who tracked down information on 43 cases Freud handled between 1907 and 1939, emphasized that he's not judging whether Freud was right or wrong in deviating from those ideas. Nor is he drawing any conclusions on how good the rules themselves are.

His point, he said, is that "if anybody thought that we could follow Freud's recommendations with the confidence that he tested them, (he or she) is going to have to rethink it."

Freud's penchant for ignoring his rules is widely known in the profession. While analysts accept the need for confidentiality, they differ in how closely they follow the two other rules, said Dr. Leon Hoffman, a New York City analyst and spokesman for the American Psychoanalytic Association.

Lynn runs the psychiatry residency training program at St. Francis Medical Center in Pittsburgh. He describes his findings in the February issue of the American Journal of Psychiatry with Dr. George Vaillant of Brigham and Women's Hospital in Boston.

To find out how Freud handled the cases, Lynn spent about eight years tracking down letters from Freud and his patients, as well as transcripts of interviews with patients. The cases he studied apparently took up the bulk of Freud's office

time from 1907 to 1939.

While Freud wrote that analysts shouldn't discuss their personal lives or emotional reactions with their patients, he did just that in all of the cases Lynn studied. For example, he chatted about his views on sexuality and marriage, the United States, other analysts and the opera Don Giovanni, even humming a few bars to a female patient.

In 37 of the 43 cases, Freud gave advice despite his rule against it. He encouraged one depressed man to follow a business career rather than law and politics and to pursue a woman the patient didn't care for.

Finally, in about half the cases studied, Freud told people who knew the patient about what was going on in therapy. In one case, another analyst had fallen in love with a patient and referred her to Freud. Freud obligingly kept the analyst posted on her sessions, including his analysis of what the woman thought of her would-be suitor.

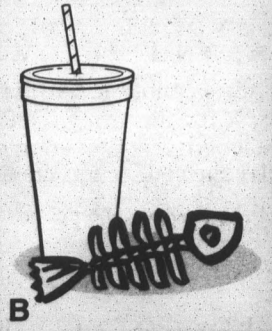
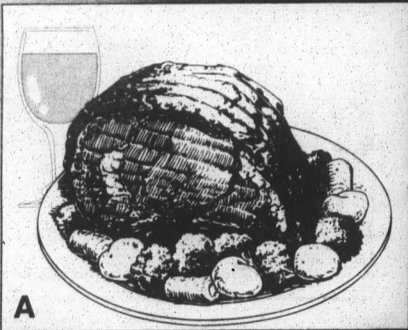
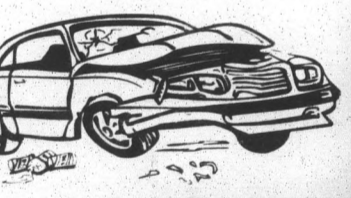
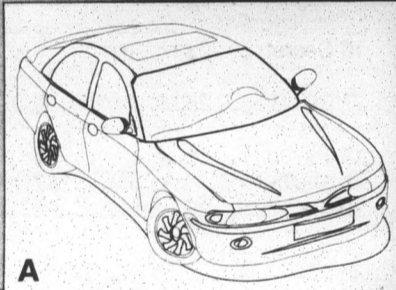
So is there any good reason for a modern-day psychoanalyst to pay attention to these rules?

Sure, said psychoanalyst Dr. Stephen M. Sonnenberg, a clinical professor of psychiatry at the Baylor College of Medicine in Houston.

"These are ideas that have been scrutinized again and again and again by very thoughtful people," he said. "[It's] not a field that where people view Freud and his writings as commandments from on high."

Still, Lynn said some experienced therapists were glad to hear that Freud himself didn't always follow the rules.

They've told him they departed from Freud's recommendations too, and "they always felt a little sheepish about it until they heard my presentation, and then they felt more confident."

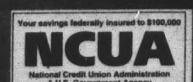

Bill aims to stop federally subsidized Internet smut access

WASHINGTON — Schools and libraries that use federal money to hook up to the Internet would have to restrict children's access to smutty material under a Senate bill offered Monday.

Sen. John McCain, R-Ariz., the Senate Commerce Committee chairman and an ardent critic of the Federal Communications Commission's Internet subsidy program, introduced the bill, which also has Democratic support.

The subsidies, which come from payments imposed on telecommunications carriers and some of their customers, provide schools, libraries and rural health-care specialists with discounted hookups to the Internet.

As a condition for getting a subsidy, a school would have to certify that it would use screening software preventing children from accessing Websites containing

indecent materials. The bill doesn't recommend a specific screening device, but leaves it to the schools to decide.

This way, a school in New York City, for instance, might decide to use a screening technology that blocks out fewer Websites, while a school in Mesa, Ariz., might opt for heavier blocking. Commercially available software such as CyberPatrol, SurfWatch, NetNanny and CYBERSitter have different standards for blocking.

Public libraries wanting subsidized Internet access also would have to certify that at least one computer available for public use is equipped with screening software, a McCain aide said.

The FCC's subsidy program provides \$675 million for schools, libraries and rural health-care providers for the first half of this year. The subsidies, the first of their kind, are likely to be disbursed in the spring.

The Commerce Committee, which has jurisdiction

over the FCC, plans to hold a hearing on the bill Tuesday. A House bill is in the works.

Senate aides contend the bill is constitutional because it doesn't directly force schools or libraries to use screening technology. They said the courts have upheld past efforts by the government to require people or groups to do certain things as a condition of receiving money through a federal program.

But when Congress, in a 1996 telecommunications law, tried to restrict children's access to smutty materials on the Internet, the Supreme Court threw the provisions out as unconstitutional.

McCain's bill is co-sponsored by the Commerce Committee's senior Democrat, Ernest Hollings of South Carolina; Sen. Patty Murray D-Wash., whose state is home to Microsoft Corp. and Sen. Dan Coats, R-Ind.

Barney's licensing company sues to bar knockoff costumes

PITTSBURGH — What? The world's most popular purple dinosaur is out smoking, drinking and swearing?

That's what the Lyons Partnership, Barney's licensing company, fears people are thinking when costume shops rent knockoff costumes of the children's TV character.

Lyons said it has sued, or plans to sue, at least 700 costume shops and other retailers in 20 states, charging that dressing like Barney is copyright infringement.

"There have been photographs in newspapers of a person in a bogus Barney costume with the head off, smoking a cigarette," Lyons spokeswoman Kelly Lane said Monday from the company's offices in suburban Dallas.

Barney, a 6-foot, grinning, green-spotted purple dinosaur, sings and dances for preschoolers on the top-rated PBS show Barney and Friends. About 12 million people see the show each week.

The company has never licensed adult-sized costumes

"because we can't police what the person does," Lane said.

Official appearances by Barney, outside of a stage show now touring the country, are rare. The company fears that the sight of Barney may cause a frenzy among young fans, even inspiring them to run across streets to hug him.

In 1996, Lyons sued three manufacturers of purple-dinosaur costumes; two of those cases have been settled. The third is pending. Lane refused to release details of the settlements.

Lyons also sought to protect Barney's image in October by filing a copyright and trademark infringement lawsuit against the Famous San Diego Chicken — Ted Giannoulas — for pretending to beat a fake Barney at sporting events.

An attorney for Giannoulas said the parody is protected under the Copyright Act, trademark law and the First Amendment. The case is pending.

Last week, the company went a step further, suing roughly 70 shops, distributors and performers in New Jersey and Pennsylvania in federal court. Lawsuits were also filed in Illinois and Georgia.

Lane declined to disclose in what other states lawsuits have been or will be filed, or to say how many lawsuits have been filed so far.

Lyons is seeking damages of at least \$100,000 per retailer and a court order that retailers hand over all purple-dinosaur costumes. Lyons offered retailers a chance to pay up and avoid the lawsuit, but only "dozens" did so, the company said.

Gary Baldowski, who owns an Eastern Onion franchise in suburban Atlanta, vowed to fight the lawsuit. His workers dress up as characters to deliver messages, sometimes bawdy, at birthday parties and other celebrations.

"I can make a purple dinosaur, but if I make it look like Barney and tell you as a customer we have a Barney, we are in total violation," he said. "We never ever did that, nor do they have any proof. We are ready to start the battle."

M. Kelly Tillery, a Philadelphia lawyer for Lyons, scoffed at retailers' claims that their purple-dinosaur costumes were not Barney.

"Who's kidding whom here? Give me a break," Tillery said.

New York City mayor, Grammy head dispute staff treatment

NEW YORK — Rudolph Giuliani will probably not be getting a "Nicest Mayor of the Year" award from the Grammys.

Giuliani is in a tiff with the head of the award ceremony and says he doesn't care if the whole production heads back to the West Coast.

"I'm not worried about it at all. If they want to go back to L.A., they can," Giuliani said. "I do not allow people to abuse members of the

mayor's staff without responding."

Giuliani claims Michael Greene, the president of the National Academy of Recording Arts and Sciences, verbally abused one of his staff, who wanted an explanation for why the mayor was cut from a nomination ceremony.

Greene "used language with her you shouldn't use and not only hasn't promptly apologized for it, but is lying about it," Giuliani said. Greene sent flowers to the aide, but she returned them.

The 40th annual Grammy Awards show,

slated for Feb. 25 at Radio City Music Hall, held a nomination ceremony in early January, in which Giuliani was invited to fill in for country crooner Clint Black.

But when the nominations were to be announced, the mayor's office was told Giuliani had been cut from the script.

When the aide asked for an explanation, Greene exploded, Giuliani spokeswoman Colleen Roche said.

According to Roche, Greene screamed, "I'm not going to let a bunch of suits come

into this party and tell me what to do."

Greene was unavailable for comment. A Grammy spokeswoman denied that there was a problem with the mayor.

Giuliani's indifference to the Grammys is a far cry from his attitude back when the Grammys moved to New York from Los Angeles.

"There really is no other city, at least in America, that can celebrate a show like this quite the way that New York can," he said at the time.

Hasbro shores up position in electronic-toy market with acquisition

NEW YORK (AP) — Hasbro Inc., struggling to keep pace with Mattel, struck a deal Monday to buy Giga Pets-maker, Tiger Electronics Inc., for \$335 million.

Hasbro, best known for G.I. Joe and Monopoly, is the world's No. 2 toymaker. Mattel is No. 1, with toys such as Barbie and Cabbage Patch Kids.

"This will help Hasbro lock up the market in handheld elec-


tronics," said Chris Byrne, editor of Playthings MarketWatch, a toy-trade publication.

In addition to Giga Pets, Tiger makes the popular Brain Warp and Lights Out.

Tiger, a privately held company in Vernon Hills, Ill., had sales of about \$400 million in 1997, while Hasbro had sales of \$1.13 billion.

Hasbro had announced just a few months ago that it would cut 20 percent of its work force and close plants to save \$350 million in the next five years.

Mattel tried to take over Hasbro with a hostile \$5.2 billion offer two years ago. The offer was withdrawn amid concerns antitrust regulators would raise objections.

LOS ANGELES (AP) — Kevin Costner and Val Kilmer are up this year for Hollywood's big phooey.

They were joined Monday by Sandra Bullock and Fran Drescher in getting nominations for Razzie Awards, the annual spoof of the Oscars honoring the worst in film.

Batman and Robin got 11 nominations, with none for star George Clooney — if you don't count the nod with co-star Chris O'Donnell for worst screen couple.

"I think *Batman* is one of the big disappointments of the year. If we had a category for the loudest and most obnoxious, it surely would win," said John Wilson, a spokesman for the Golden Raspberry Foundation.

Speed 2: Cruise Control got eight nominations, including one for Bullock as worst actress.

Razzie nominations were announced the day before Academy Award contenders. The winners will be released March 22, the day before the Oscars.

In the worst picture category, *Batman and Robin* and *Speed 2: Cruise Control* were joined by *Anaconda*, *The Postman* and *Fire Down Below*.

Worst actor nominees were Kevin Costner for *The Postman*, Val Kilmer for *The Saint*, Shaquille O'Neal for *Steel*, Steven Seagal for *Fire Down Below* and Jon Voight for *Anaconda*.

Bullock was joined for worst actress by Fran Drescher for *Beautician & The Beast*, Lauren Holly for performances in two movies — *A Smile Like Yours* and *Turbulence* — Alicia Silverstone for *Excess Baggage* and Demi Moore for *G.I. Jane*.

MEMPHIS, Tenn. (AP) — Former NAACP leader Benjamin Hooks and his wife were hurt in a two-car accident that critically injured the other car's driver.

Frances Dancy Hooks was driving their Mercedes Sunday night when Jintana Borisuth's car clipped its left rear, police said. The Mercedes went into the guardrail and Borisuth hit a concrete wall, flipped and landed upside down.

The injuries to Borisuth, 24, were not disclosed. Hooks bit his tongue and Mrs. Hooks broke her wrist. Both were treated at a hospital and released.

For 16 years, Hooks was president of the National Association for the Advancement of Colored People. He is pastor of the Greater Middle Baptist Church in Memphis, and an adjunct professor in history and political science at the University of Memphis.

LONDON (AP) — A fund to lend a financial hand to Louise Woodward is fast running dry, her father said Monday.

The agency that employed the 19-year-old British au pair paid for her legal costs through her trial but has since ended the support.

"Basically, we couldn't afford a retrial. The fund has paid for the past two months' legal fees. The fund is disappearing rapidly," Gary Woodward told BBC Radio.

A jury in Cambridge, Mass., convicted Ms. Woodward of second-degree murder in November in the death of 8-month-old Matthew Eappen.

After the judge reduced the conviction to manslaughter and set her free, the Woodward family declared they were determined to clear her name entirely. But their lawyer said late last month the family no longer wants a retrial.

A prosecution challenge to the reduction in the conviction is due to be heard March 6. If it fails, Ms. Woodward would be free to return to her hometown of Elton. For now, she can't leave Massachusetts.

In Elton, the head of the support fund said \$330,000 remained.

Much of the money was spent on Ms. Woodward's housing, as well as on housing for her parents and their transportation between the two countries.

PHOENIX (AP) — Motley Crue bassist Nikki Sixx pleaded innocent Monday to a misdemeanor alleging he and Tommy Lee assaulted a security guard during a concert in December.

Sixx faxed in the plea, as did Lee, on Thursday. Another hearing for the two was scheduled for Feb. 27.

The guard was trying to hold back fans who rushed the stage at America West Arena, and started dancing after members of the band told them to leave their seats.

KATMANDU, Nepal (AP) — Gurkha veterans campaigning for a better pension from the British government said Monday a visit from Prince Charles had given valuable publicity to their cause.

Charles left Katmandu on Monday after three days and went to Bhutan on the last leg of a three-nation South Asian tour.

"We are very optimistic that the visit by the Prince of Wales would help our campaign due to the media coverage of the Gurkha issue in the last three days," said Hem Bahadur Gurung of the Gurkha Ex-Servicemen's Organization.

Charles is the colonel-in-chief of the Royal

NEW YORK (AP) — City streets may be safer, but stepping off the curb — well, that's another matter.

"When I'm walking along, those cabs are horrible, they really are," Iris Vargas said, stepping back gingerly from the curb as a taxi roared by.

Crime is down in New York City, but the number of injuries involving taxis and livery cabs has jumped by nearly two-thirds this decade, according to the Department of Motor Vehicles.

To crack down the notoriously wild maneuvering of New York City's cab-drivers, Democratic Assemblyman Scott M. Stringer proposes placing "How's My Driving?" bumper stickers on cabs featuring a phone number where operators will

take down complaints.

"There's a group of cabbies that clearly needs help. We can't have drivers amputating people's limbs," Stringer said, referring to an accident last month in which a woman's leg had to be amputated after a careening cab pinned her to a light post.

A spokesman for the city Taxi and Limousine Commission blamed many accidents on illegal gypsy cabs, while one veteran cabbie blamed the increase in taxi crashes on the nature of the job.

"Drivers have to work longer hours to make a living," said Douglas Chess, who has been driving for 23 years. "That means they're more tired on the job and more prone to accidents."

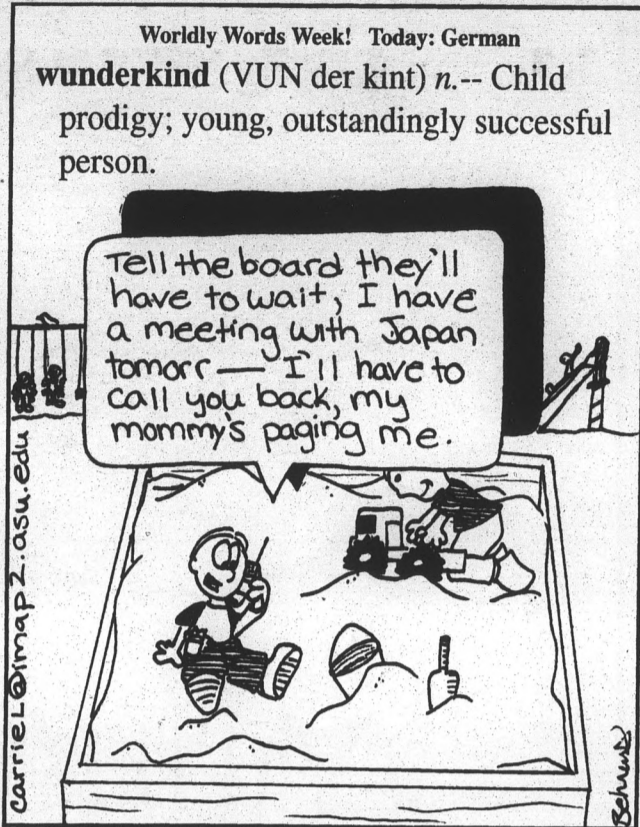

The fact that the ASU men's tennis team has a record of 0-3 is no one's fault but its own. This is not to say the team has played poorly, in fact they have played quite well, or that the coaches have not done their jobs, because they have.

It is, however, to say that the Sun Devils were the ones responsible for scheduling consecutive road matches against three of the top 10 teams in the country to open up their season.

After beginning the 1998 dual season at No. 9 Florida, ASU continued its road trip with a visit to Los Angeles to open Pac-10 play against No. 10 USC and No. 2 UCLA. That part of the schedule, however, is over and its time to put the bitterness of the losses behind them put what they have learned against these upper tier teams into action against the rest of their opponents.

That's where the University of Utah's Runnin' Utes come into play. ASU will host Utah today at 1:30 p.m. at the Whiteman Tennis Center in its home opener. The match could not come at a better time for head coach Lou Belken, who calls it a good opportunity for his squad to get back on track.

"It's going to be great to get back home," Belken said. "Utah is traditionally a team we play early in the season and they are always a rough match for us, I expect (today) will be a rough match too."

Belken said the road trip was a good experience for the team and they learned some things they can use in the future. However, they did not get what they wanted; a win.

"Close doesn't make anybody happy now," Belken said. "We feel we were capable of playing with anybody. We had our chances to win all three of those matches, but we didn't"

Veal receives honor

ASU shooting guard Jeremy Veal has been named Pac-10 Player of the Week for his efforts on Feb. 5 against Washington State and Feb. 7 against Washington.

The senior averaged 21.0 points and 3.5 assists in the Sun Devils' home sweep of the two schools.

Veal dropped in 20 points on 5-of-13 shooting, dished out five assists, grabbed three steals and one rebound in the 82-68 triumph over Washington State.

He then put up 22 points on 9-18 shooting while adding two assists and two rebounds in ASU's 94-85 win over the Huskies.

For the week, Veal shot 14-31 (.452) from the field, 6-of-8 (.750) from three-point range and 8-of-8 from the line.

This is the first time the San Dimas, Calif., native has received such an honor. He is the 11th ASU player to be named Player of the Week and the first since Mario Bennett in 1995.

The wins moved the Sun Devils up in the Pac-10 standings to a fourth-place tie with Washington at 6-5. Their overall record now stands at 16-8, guaranteeing ASU its first winning record since the 1994-95 campaign.

ASU hockey iced for ineligible player

It was the best of times. It was the worst of times.

There is no doubt that when Charles Dickens penned his novel "A Tale of Two Cities," he wasn't referring to the ASU Ice Devils.

But there is little doubt that the 1997-98 hockey season is a tale of two seasons. First there was the best of times, as ASU's fledgling Division I club team — highlighted by a 4-0 season record against state rival UofA and a program-best No. 6 ranking — received its second-ever American College Hockey Association National Tournament invitation.

Today, however, is the worst of times. Amid a clouded mess of accusations, rumors, miscommunication, mishaps and suspicion, ASU has been suspended from the national tournament and faces further penalties for using an ineligible player.

At the head of this sordid situation stands the player in question, senior defenseman Keith McElroy, and Ice Devils general manager Mike Hoffarth. On the outskirts is the ASU registrar and the ACHA Board of Directors.

In the middle is the Ice Devils hockey club.

"This is gut-wrenching," junior

goaltender Greg Powers said. "Twenty-seven guys on this team worked the whole season towards the national tournament and we definitely had a legitimate shot. Now it's all over. It's like somebody took a knife and ripped my heart out."

It was back on Nov. 1, in compliance with ACHA policy and bylaws, that Hoffarth submitted a 1998 Fall semester registration verification for the Ice Devils. McElroy, who, after his spring 1997 GPA fell below a 2.00, had registered for three classes at ASU and four classes at Mesa Community College, was listed as registered. But on Dec. 1, Hoffarth received a letter from ACHA commissioner John Drum stating that McElroy had been dropped from his ASU classes shortly after the November forms were sent out and his eligibility was in question.

After submitting the required registration forms on Feb. 1 for the 1998 spring semester, Hoffarth received a letter last Thursday stating that the ACHA Board of Directors unanimously ruled that McElroy was ineligible. The penalties were not only swift but harsh.

In addition to forfeiting all five games that McElroy played in last semester and the national tournament suspension, ASU was placed on probation for the 1998-99 and 1999-

2000 seasons. The Ice Devils will also receive an audit of its player eligibility covering the past three years.

"When I received the letter saying there might be a problem, I contacted (the ACHA) immediately," Hoffarth said. "Because there was no response I assumed there was no problem. There is a legal term called a Tacit Agreement, where if somebody requests information and there is no response, then it is an agreement."

"He was listed as not registered, but that was wrong," Hoffarth added. "By reading (the registrar transcript), you can see the registrar was wrong."

According to Hoffarth — who, in defense of the Ice Devils program, said that over the last two semesters the team ruled four players ineligible, including one of ASU's all-time point-scorers, Shawn Reid — the mistake was not only made by the ACHA and the registrar, but by McElroy himself.

"I really think that he thought he met eligibility requirements," said Hoffarth, who stated that he had no knowledge that McElroy might be ineligible until this month. "But I think the blame lies with Keith McElroy for not saying anything. He told me he was going to his classes at ASU, and now we find out that no (he wasn't going to class).

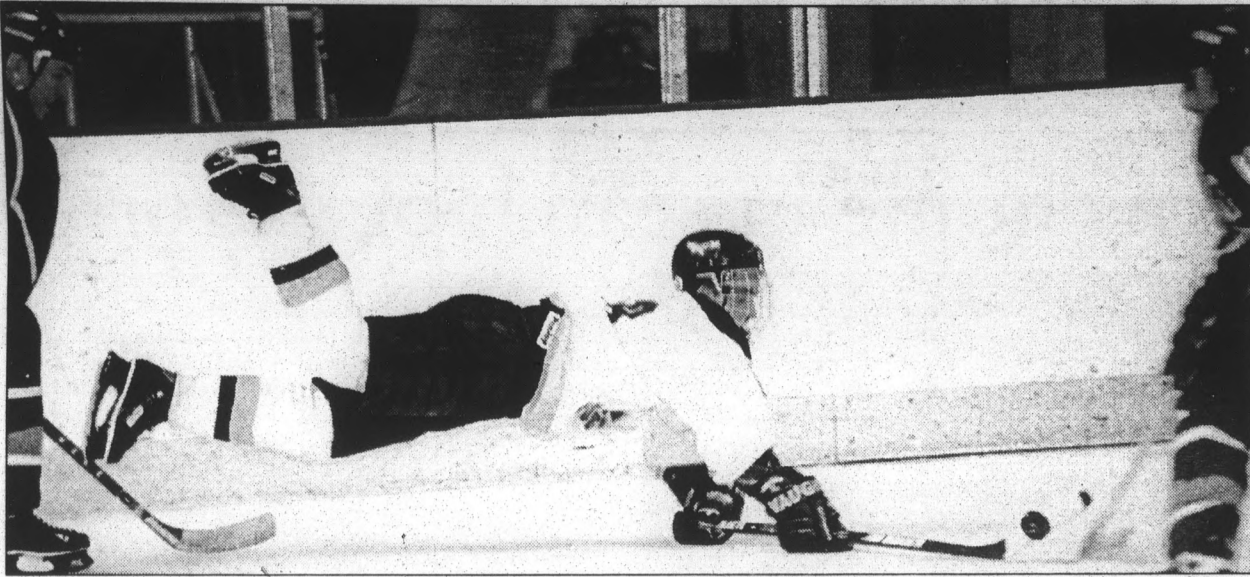

"Why would I try to cover up something like this? I wouldn't jeopardize the once-in-a-lifetime chance for some of the players to play in the national tournament."

McElroy, however, claims that Hoffarth is covering up and leaving him out to dry.

"I'm not going to let (Hoffarth) tell everybody on the team and at this school that I'm the one who screwed up," McElroy said. "I take my blame for originally failing the class, but I'm not going to take the fall for this. He told the team face-to-face that he knew nothing about it. I'm not going to lie to my teammates who I would die for and say he didn't know. He knew from the beginning."

"I was doing what I was told by him, and he sold me out. I'm insulted that he's wearing the same logo on his jacket. I don't mean to rip into Hoffarth so hard, but everybody knows the truth now."

With the once-promising season now on permanent ice, somehow the team must move on. But the repercussions are

already being felt.

"Hopefully I'll be able to stay because I love it here," said Powers, who started every game but two in net for ASU this season. "But if there is no light at the end of the tunnel, chances are I'll probably be out of here."

For head coach Gene Hammett, who feels the school "dropped the ball" by not deleting McElroy's registration earlier, the "huge, huge, huge miscommunication" between Hoffarth, the ACHA and the registrar has put to rest his hopes for a national championship.

"It's horrible because we have a bunch of kids here who are not going to the nationals that deserve to go," Hammett said. "I don't see Keith at wrong here — he tried to do everything the right way. I don't think Mike (Hoffarth) was wrong — because he tried to contact the ACHA. All we can do for now on is be very cognizant of the grades of every kid that plays here."

"It's just a black eye for the program."

and right now we need to beat Utah and concentrate on that match."

One thing ASU learned from their road trip was that they are playing some of the best doubles in the country right now. ASU won the doubles point in all three matches, giving them a distinct advantage going into the singles competition.

In the Sun Devils 4-3 loss at USC, Ed Carter and Tim Hammond defeated USC's George Bastl and Kyle Spencer, 8-5. (Bastl and Spencer were

the NCAA runner-ups last year and were the preseason No. 1 duo coming into this season).

While the doubles play was a bright spot for ASU on the road, their singles play failed them in the clutch. Other than a win by Gustavo Marcaccio against USC's George Bastl (the No. 8 player in the country) and a win apiece by Alex Osterrieth and Tim Hammond the Sun Devil's singles play was tepid, effectively erasing any chances to close out the always difficult road upsets.

"The doubles has been good for us, but it doesn't mean anything unless you can get three singles wins to go along with it," Belken said.

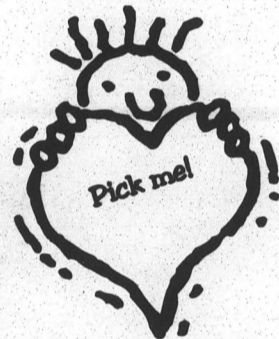

Mason declares innocence on statutory rape charges

NEW YORK (AP) — An embarrassed Anthony Mason apologized to his family and teammates Monday and denied charges that he had sex with 14- and 15-year-old sisters.

"Did I do this? No, definitely not," the Charlotte Hornets forward said following the team's practice at an Upper West Side fitness club. "I'm innocent."

Mason was charged Sunday with statutory rape, sexual abuse and endangering the welfare of a child following accusations by the girls that he and a cousin had sex with them. Mason, who was released on \$20,000 bail, faces up to four years in prison if convicted.

"I'd like to say I'm sorry to my family and for the embarrassment of this situation," Mason said. "Once again, it's a silly situation. I'd like to say sorry for the embarrassment to the team."

After making his short statement, Mason hurried out of the Reebok Sports Club and boarded a chartered bus with his teammates for the short trip back to the Plaza Hotel. The Hornets play the Knicks Tuesday night.

Before joining Mason on the bus, his agent, Don Cronson, reiterated his client's stance.

"He did nothing wrong, nothing illegal,"

Cronson said. "Nothing, nothing, nothing." Cronson was asked if Mason had an alibi.

"Alibi? I don't know if that's the correct term," he said. "He's innocent of the charges, that's his alibi. He didn't do it."

Many of the Hornets looked surprised when the team arrived for Monday practice to find TV crews and reporters staked out. The players and coach Dave Cowens refused to comment.

In their complaint, the girls said Mason and his cousin, William Duggins, an unemployed construction worker who was also charged, met them during a benefit basketball game then drove to Duggins' home.

Mason, who was in town visiting family over the weekend during the All-Star break, is accused of having sex with the girls in a basement bedroom at the house. The sexual abuse charge stemmed from events in a limousine on the way there, according to the complaint.

Cronson said Mason was in the car with the girls but that all they were doing was "driving around."

Meanwhile, the Queens district attorney's office has asked Mason for a blood sample, which the basketball player will provide on March 9 when he next appears

in court. Mason was one of the Knicks' most popular players before being traded to Charlotte in 1996. But while he was with the club, he had other scrapes with the law.

In late 1995 and early 1996, the 6-foot-8, 250-pound Mason was involved in two

fight at Manhattan nightclubs. In one, he was accused of hitting a woman; in the other, he said he was trying to break up a fight.

Later in 1996, Mason was charged with felony assault during a scuffle with police over a Times Square parking ticket.

Woods tops list of ESPY award winners

NEW YORK (AP) — It was another night of honors for Tiger Woods.

Woods was the top winner at the sixth annual ESPY Awards show Monday night, taking home three ESPYs for excellence in sports performance, including the co-Male Athlete of the Year with Ken Griffey Jr. Woods, the PGA Tour 1997 player of the year, also won the Performer of the Year and the Showstopper of the Year for his victory at the Masters.

"Last year was pretty amazing. I could have been studying for finals and midterms, but I got my Masters instead," Woods said.

Michael Jordan, who did not attend the show, was the only other multiple winner, taking honors as top performer in the professional basketball and Dramatic Individual Performance for his 38-point, flu-ridden performance in Game 5 of the Finals against Utah.

Jordan's college coach, Dean Smith, was honored with the Arthur Ashe Award for Courage. Smith, who became the winningest coach in college basketball history in March before retiring in October, received the award with six of his former players — Billy Cunningham, Doug Moe, Charlie Scott, Walter Davis, Brad Daugherty and James Worthy.

Smith, visibly emotional at the sight of his former players on the stage and a tribute to his career on the screen, initially turned down the award because he said he wasn't as worthy as past winners.

"I watched Jim Valvano fighting for his life when he got the award and he was still fighting to find a cure for his disease," Smith said. "I saw Muhammad Ali up here helping kids while he was fighting his disease."

Smith agreed to accept the award after Ashe's widow,

Jeannie, called and told him that her husband would be pleased with the committee's choice. Smith, a long-time supporter of the civil rights movement, helped integrate North Carolina during the 1960s.

"I want to thank people for pushing me to do what was right," Smith said. "Forty years ago, that was racial reconciliation. But there is still more work to be done."

One of the more emotional moments of the show came when former Detroit Lions linebacker Reggie Brown accepted the award for best pro football player on behalf of Barry Sanders. Brown, who sustained a career-ending spinal cord injury the same day Sanders eclipsed the 2,000-yard rushing mark, walked on stage with a metal "halo" to a standing ovation from the crowd at Radio City Music Hall.

Other top awards went to Mia Hamm (Female Athlete of the Year), the Denver Broncos (Team of the Year), and Jim Leyland, manager of the Florida Marlins (Coach/Manager of the Year).

The University of Tennessee had a double victory of sorts as Volunteers Chamique Holdsclaw and Peyton Manning won Women's College Basketball and College Football Performer of the Year, respectively.

The awards show, sponsored by the ESPN cable network, celebrated memorable sports moments of the past year like Nebraska's "Immaculate reception" to force overtime vs. Missouri, Evander Holyfield retaining his heavyweight title and Jeff Gordon's second Winston Cup points title.

Overall, awards were presented in 35 categories, including 18 Performer of the Year awards, seven Cross-Cutter categories with nominees from any sport and 10 Fan's Choice awards.
